- AB 1329 (Wolk) Design-build contracting for cities in Solano and Yolo Counties. C/CAG position Support. Status Chaptered.
- AB 1358 (Mullin) ALUC review of new school sites for charter schools. C/CAG position Support. Status – Chaptered.
- AB 2538 (Wolk) Increased Planning and Programming funds for Congestion Management Agencies. C/CAG position Support. Status Chaptered.
- AB 2681 (Pavley) Increased vehicle registration fees for Abandoned Vehicle Abatement programs. C/CAG position Support. Status Vetoed.
- AB 2987 (Nunez) State regulation of cable and video service. C/CAG position Oppose. Status Chaptered.
- 5.2 Review and approval of Candidate Projects and Authorize the C/CAG Executive Director to work with the Metropolitan Transportation Commission (MTC) and CALTRANS to make final selection from the Candidate Project List to be submitted for funding consideration in the Corridor Mobility

Improvement Account (CMIA) of the Transportation Infrastructure Bond (Proposition 1B, subject to voter approval on November 7, 2006). APPROVED

On 11/7/06, California voters approved the \$19.9 billion Transportation Infrastructure Bond. The \$4.5 billion CMIA is for congestion relief on the state highway system. Project selection for the CMIA will primarily be at the California Transportation Commission's (CTC) discretion. Projects nominated for this category shall be submitted to MTC by December 1, 2006 and to the CTC by January 15, 2007. Staff is asking the Board to approve the list of priority candidate projects, approved at the 8/10/06 C/CAG Board meeting, and to authorize the Executive Director to work with the region and the State to come up with the final projects.

Board Member Jacobs-Gibson MOVED to approve Item 4.8. Board Member O'Mahony SECONDED. MOTIONED CARRIED 16-0.

5.3 Review and approval of the process to make an appointment to fill the vacant seat for a public member for a two-year term to the C/CAG Bicycle and Pedestrian Advisory Committee.

Candidates for the C/CAG Bicycle and Pedestrian Advisory Committee (BPAC) will interview at the 12/08/06 C/CAG Board meeting. Each candidate will be given two minutes to interview in front of the Board and share why they should be selected to sit on the BPAC. After hearing all the candidates, the Board will make a decision by casting their votes.

5.4 Update on the Sub-regional Housing Needs Allocation Process (RHNA) within San Matco County. INFORMATION

Twenty cities plus the County, in San Mateo County, are the first group in the Bay Area and the State to make use of the State legislation allowing cities and counties to form a sub-region to plan how to accommodate State requirements to develop housing for population growth. C/CAG has been selected as the entity to manage the process for the San Mateo County Sub-Region. Over the next 18 months C/CAG, together with the cities and the County, will establish housing shares for the 2009 Housing Elements. The first RHNA Technical Advisory Committee (TAC) was held on 10/25/06.

5.5 Review and approval of a draft Program for the reauthorization of the Congestion Relief Program and authorize distribution of the Draft Congestion Relief Program for comments. APPROVED

The Congestion Relief Program, including the programs funded and operated under it, will expire 6/30/07. Feedback from the TAC, CMEQ, and City Managers Association is positive as to what the program accomplished.

Staff provided two different options for the Board to consider what would be the best plan to follow in renewing the Program. Board Members will take the reports back to their cities for discussion. The Board consensus was Final decision will be made at the January 2007 C/CAG Board meeting.

Board Member Gordon MOVED approval of Option 1. Board Member O'Mahony SECONDED. MOTIONED CARRIED 15-1 with Board Member Matsumoto voting against the motion.

Staff was directed that both Option 1 and Option 2 be provided to the Cities and County and that each Board Member take the necessary action to be prepared to vote on the item at the January 2007 Board Meeting.

#### BACKGROUND/DISCUSSION

Nicholas P. Jellins served on the C/CAG Board of Directors from January 2003 through December 2006, during which time he served as Vice Chair from March 2005 through December 2006.

#### **RECOMMENDATION:**

It is recommended that the C/CAG Board review and accept the Quarterly Investment Report.

#### ANALYSIS

C/CAG's only investment vehicle to date has been the Local Agency Investment Fund (LAIF). The balance in the Local Agency Investment Fund as of September 30, 2006 was \$4,571,282 earning 4.93% interest. Total accrued interest for the quarter ending September 30, 2006 was \$41,301.

Below is a summary of the changes in the portfolio:

In August, Staff transferred \$2,250,000 from the checking account into LAIF after reviewing the immediate cash flow needs of the Agency. This transfer has increased the interest income for the quarter ended September 30, 2006 by \$15,428 or 63% over the quarter ended June 30, 2006.

On August 10, 2006, the C/CAG Board authorized the opening of an investment account with the San Mateo County Investment Pool. In October, Staff began the process of opening the investment account. Once the account has been opened, Staff will review balances in both the checking and LAIF accounts and transfer funds into the SM County Investment Pool to better diversify the portfolio.

Historical cash flow trends are compared to current cash flow requirements on an ongoing basis to ensure that C/CAG's investment portfolio will remain sufficiently liquid to meet all reasonably anticipated operating requirements. As of September 30, 2006, the portfolio contains enough liquidity to meet the next six months of expected expenditures by C/CAG. All investments are in compliance with the Investment Policy.

The City's Investment Advisory Committee has reviewed and approved the attached Investment Report.

#### **RECOMMENDATION**

#### FISCAL IMPACT

\$200,000 has been budgeted for the Ramp Metering program in the 2006/07 C/CAG budget.

#### SOURCE OF FUNDS

Funding for the ramp metering program is from the C/CAG Congestion Relief Plan. The San Mateo County Transportation Authority (SMCTA) has agreed to pay C/CAG up to \$100,000 from Measure A funds as a dollar for dollar match to C/CAG funds for the purpose of funding the ramp metering implementation. As such, the cost sharing between C/CAG and SMCTA is at 50% each, up to a total of \$200,000.

A request has been made to the Metropolitan Transportation Commission (MTC) to contribute up to \$86,395, 50% of the \$172,790 needed to conduct this "before" and "after" traffic monitoring. If a funding agreement can be reach with MTC, the cost to C/CAG and SMCTA will be reduced by the dollar amount funded by MTC.

#### BACKGROUND/DISCUSSION

At its November 10, 2005 meeting, the C/CAG Board approved the ramp metering program and authorized the Ramp Metering Technical Committee to define the specific operational parameters of the ramp metering program, subject to the approval of C/CAG Executive Director. Since then, the Ramp Metering Technical Committee has met on a monthly basis and developed operational details of the ramp metering program.

**ITEM 4.7** 

The Committee has identified 22 specific local street intersections and 19 local roadway segments for traffic condition monitoring before and after ramp meters are turned on, for the purpose of monitoring ramp metering impacts on local street traffic operations. C/CAG has committed to conduct the local streets traffic monitoring at no additional cost to the cities. The funding agreement with Fehr & Peers Associates is for consulting services to conduct the local streets "before" and "after" traffic monitoring.

Fehr & Peers is pleased to submit this proposal to conduct the monitoring study for the US 101 Ramps in San Mateo County. Our approach, scope, and cost estimates are discussed below.

#### Project Understanding/Approach

The purpose of the monitoring study is to measure the change in traffic at selected intersections and roadway segments in San Mateo County when the ramp meters at the US 101 ramps are turned on. The twenty-two (22) study intersections and nineteen (19) roadway segments will be surveyed three times (once before the meters are turned on and twice afterwards). The changes in the traffic volumes and operations of the study intersections will be noted.

#### Scope of Work

The following tasks will be conducted:

- Data Collection (Before Ramp Meters are On) Conduct 3-hour AM and PM peak-period turning movement counts over two (2) days at twenty-two (22) intersections. Conduct two-week machine counts for the nineteen (19) roadway segments. These counts will be conducted In January 2007. Observations at the study intersections will be conducted to observe operations.
- Data Collection (After Ramp Meters are On) Traffic counts at the same study locations will be conducted twice (in March and September 2007) after the ramp metering is implemented. The intersection counts will be conducted during the same AM and PM peak periods and observations will be conducted. Roadway segment counts will be conducted for a two-week period.
- 3. Conduct LOS Calculations and Volume Comparisons Intersection level of service calculations will be conducted using the results of the turning movement counts that were collected before and after the ramps were turned on. Similarly, the roadway segments counts during the "after" phase will be compared to the "before" phase to determine the change in traffic patterns.
- 4. Documentation Fehr & Peers will prepare a technical memorandum that compares the "after" counts (March 2007) to the "before" counts (January 2007). The net change in roadway segment volumes and intersection operations will be presented. This proposal assumes up to 8 hours of staff time to respond to comments. The memo will be updated in October 2007 to reflect the second round of traffic counts. Up to 8 hours of staff time is included to respond to the updated memo.
- 5. Meetings Attendance by Fehr & Peers staff at one staff meeting is included.

#### Fee Estimate

The number of person hours for each task, the estimated number of counts and surveys, the cost per count/survey, and the total cost of the monitoring effort is presented below.

#### **RECOMMENDATION**

Review and approve Resolution 06-42 authorizing projects to be implemented by the San Mateo Countywide Stormwater Pollution Prevention Program and funded by C/CAG's Vehicle Registration Fee (AB1546) Program.

#### FISCAL IMPACT

Not to exceed \$601,440.85.

#### SOURCE OF FUNDS

Funds will come from the programmatic portion of stormwater funds collected through vehicle license fees under AB1546. For fiscal year 2005-06, this equals \$601,440.85.

#### BACKGROUND/DISCUSSION

C/CAG's Vehicle Registration Fee Program (AB1546) authorized a four dollar increase in vehicle license fees in San Mateo County to provide funding for congestion management and stormwater pollution prevention. Half of the fees collected arc for stormwater pollution prevention, and of those funds, half goes to the municipalities for reimbursement of local vehicle-related stormwater pollution prevention projects and half to the countywide stormwater program for program-level projects addressing vehicle-related stormwater pollution. The increased fee went into effect on July 1, 2005 and terminates on January 1, 2009, unless reauthorized by the legislature. The programmatic portion of the stormwater funds is approximately \$600,000 for fiscal year 2005-2006.

The Technical Advisory Committee for the countywide stormwater program proposes to initially implement two projects with the 2005-06 programmatic portion of the AB1546 stormwater funds: 1) Sustainable Streets and Parking Lots for San Matco County, and 2) Car Wash Kits for Fundraisers. These projects are described in more detail as follows:

**ITEM 4.8** 

- Sustainable Streets and Parking Lots for San Mateo County: The focus of this project is on two items: 1) developing a stormwater design standards guidebook for municipalities to use in planning new and revitalizing existing urban streets and parking lots to achieve multiple water quantity and quality benefits, and 2) funding demonstration projects. To help with the first item and to develop a detailed project scope and cost breakdown, the countywide program is consulting with a group of technical advisors with expertise in sustainable street programs. For the second item, program staff are looking at the El Carnino Real "Grand Boulevard" initiative as a potential way to fund demonstration projects, in addition to any other municipal street or parking lot projects. The stormwater design standards guidebook would be available on the San Mateo Countywide Stormwater Pollution Prevention Program's website for all interested users. This project is intended to be a multi-year project, but would not exceed the funding sunset date of January 1, 2009. Detailed project costs and scope are still being developed for this project and will be provided to C/CAG in the future; however, project costs will be limited to \$570,000 for fiscal year 2005-06 AB1546 funds.
- Car Wash Kits for Fundraisers: This project will provide car washing kits to
  municipalities to loan to fundraising groups to prevent discharge of vehicle washwater to
  the storm drain system. This has been identified by municipal staff as an ongoing
  concern due to the high visibility of these types of activities and the prohibition of vehicle
  washwater to the storm drain system in the countywide stormwater permit. Availability
  of the kits will be advertised to schools and other service groups, since most car washing
  events do not require permitting by municipal agencies. The project will provide a nocost tool which will allow ongoing car washing activities for fundraising events but help
  prevent vehicle-related pollutant discharge to the Bay. Project costs will be limited to
  \$30,000 for fiscal year 2005-06 AB1546 funds.

#### BACKGROUND/DISCUSSION

In April 2002, the C/CAG Board approved Resolution 02-13 approving C/CAG to enter into a Cooperative Agreement with the SMCTA and VTA for a study to identify transportation issues related to highway operations and congestion levels on US 101 between Hwy 84 and Hwy 85 and the connection of US 101 to the Dumbarton Bridge. The original project cost of \$500,000 was divided up as follows: C/CAG contributes 25% (\$125,000); SMCTA contributes 25% (\$125,000); and VTA to contribute 50% (\$250,000).

The "2020 Peninsula Gateway Corridor Study" is ongoing and to date has generated various preferred alternatives and recommendations for improvements to congestion issues on the US 101 and connecting highways to the Dumbarton Bridge. The parties determined that the analysis data generated by the study could contribute to the development of the project study report (PSR) equivalents for candidate projects for submission to the Corridor Mobility Improvement Account (CMIA) funding program. Therefore, in November 2006, the C/CAG Board approved Resolution 06-35 authorizing the "2020 Peninsula Gateway Corridor Study" consultant, Kimley-Horn and Associates, to develop PSR equivalent documents for the US 101 Auxiliary Lanes and Bayfront/Willow Road Interchange and prepare project nomination documents.

The cost breakdown for this additional work is as follows:

#### SOURCE OF FUNDS

The source of the Regional Rideshare Program funds is from the Metropolitan Transportation Commission under the Federal Congestion Mitigation and Air Quality program.

#### BACKGROUND/DISCUSSION

MTC sponsors the Regional Rideshare Program (RRP) for the nine Bay Area counties utilizing an outside contractor. In addition to maintaining a central database for helping commuters to join car and van pools, MTC's contractor also works with local employers to establish trip reduction programs for workers and conducts a wide array of marketing efforts promoting alternatives to commuting in single occupant vehicles.

**ITEM 4.10** 

C/CAG entered into a funding agreement with MTC in June 2005 to receive funding in an amount up to \$420,000 over six fiscal years for the performance of Regional Rideshare Program activities in San Mateo County. C/CAG contracts with the Peninsula Traffic Congestion Relief Alliance to perform Transportation Demand Management activities for the RRP in San Mateo County.

MTC's contractor operates the 511 Ridematch Tool Database that contains address and contact information for commuters interested in receiving matchlists from the 511 Regional Rideshare Program. A Memorandum of Understanding with MTC will need to be executed in order to allow the Peninsula Traffic Congestion Relief Alliance access to the 511 Ridematch Tool Database.

Additionally, there is a need to amend the funding agreement dated June 30, 2005 with MTC for the Regional Rideshare Program. The Amendment No. 1 will remove specific annual targets from the agreement so that the agreement will not have to be amended each year if the targets change.

#### MEMORANDUM OF UNDERSTANDING between METROPOLITAN TRANSPORTATION COMMISSION and the CITY/COUNTY ASSOCIATION OF GOVERNMENTS OF SAN MATEO COUNTY

This Memorandum of Understanding (MOU) is entered into this 14th day of December, 2006 by and between the Metropolitan Transportation Commission (hereinafter "MTC") and the City/County Association of Governments of San Mateo County (hereinafter "CMA").

#### RECITALS

WHEREAS, the 511 Ridematch Tool Database ("RMS Database") contains address and contact information for commuters interested in receiving matchlists from the 511 Regional Rideshare Program ("RRP"); and

WHEREAS, CMA operates a county-wide Transportation Demand Management (TDM) program to facilitate the formation of carpools and vanpools within its communities; and

WHEREAS, CMA wishes to obtain access to the RMS Database to support its efforts; and

WHEREAS, MTC wishes to grant CMA access to the RMS Database to support local and regional ride-sharing efforts, subject to CMA agreeing to comply with the restrictions set forth herein;

NOW, THEREFORE, the parties hereto agree as follows:

#### ARTICLE I MTC RESPONSIBILITIES

1. MTC agrees to grant CMA access to the RMS Database, subject to the conditions contained below in this MOU.

#### ARTICLE II CMA RESPONSIBILITIES

- 1. CMA, through its countywide TDM program, may:
  - Add new registrants, update registrant information, delete registrants, and facilitate matches among commuters but only to the extent that those registrants have registered an origin or destination within CMA's geographic jurisdiction.

- Make placement calls to commuters and respond to their requests as long as the commuters have registered an origin or destination within CMA's jurisdiction.
- Utilize the database to generate statistics and reports for its internal use, and
- Initiate contact (e.g., phone, mail, or email) with registrants registered in the RMS Database but only after first coordinating with the 511 RRP Contractor and receiving approval from the MTC RRP Program Manager.
- 2. CMA, through its countywide TDM program, shall:
  - Keep all personal information confidential. Personal information includes a registrant's name, address, telephone number, e-mail address, or other information that personally identifies a registrant. Personal information shall only be used by CMA for the purpose of performing the functions set out in this Article I. Other than disclosing a registrant's phone number(s) and email address(es) to other registrants in the RMS Database, personal information shall not be disclosed to third parties, except as required by law, ordered by a court of competent jurisdiction, or where the express written consent of the registrant has been obtained.
- 3. Prior to adding call-in registrants to the database, CMA, through its countywide TDM program, shall inform the registrant of the following conditions and receive his/her consent thereto:
  - The registrant may receive phone calls, e-mail, and/or postal mail from CMA's countywide TDM program and/or the 511 Regional Rideshare Program.
  - The registrant may be contacted by others registered in the ridematching database.
  - Information provided by the registrant is used for ridesharing purposes only.
  - Other registrants in the database will be able to view the registrant's phone number(s) and e-mail address(es) provided, and
  - Registrants in the database have not had background checks.
- 4. When creating or providing mail-in or fax-in database registration forms, CMA, through its countywide TDM program, shall ensure that the ridematching system privacy/liability statement is included on the form. The statement is available from the 511 RRP Contractor.
- 5. CMA, through its countywide TDM program, shall establish rules of conduct for persons involved in the functions set out in this Article I with respect to personal information and instruct each such person with respect to such rules.
- 6. CMA, through its countywide TDM program, establish appropriate and reasonable administrative, technical and physical safeguards to ensure the security and confidentiality of

records and to protect against anticipated threats or hazards to their security or integrity, which could result in any injury.

#### ARTICLE III GENERAL PROVISIONS

- 1. The term of the MOU shall be from the date first specified above, continuing indefinitely until terminated by either party. Either party may terminate this MOU at any time.
- 2. This MOU does not constitute an authorization for funding or project effort. All obligations of CMA and MTC under this MOU are subject to the appropriation of resources by their respective governing bodies.
- 3. This MOU may be amended from time to time with the written consent of the parties.

#### AMENDMENT NO. 1 TO FUNDING AGREEMENT Between METROPOLITAN TRANSPORTATION COMMISSION And CITY/COUNTY ASSOCIATION OF GOVERNMENTS OF SAN MATEO COUNY (C/CAG) For PERFORMANCE OF REGIONAL RIDESHARE PROGRAM ACTIVITIES

# THIS AGREEMENT, effective as of December 14, 2006 is Amendment No. 1 to the Agreement by and between the Metropolitan Transportation Commission ("MTC") and the City/County Association of Governments of San Mateo County ("C/CAG" or "RECIPIENT"), dated June 30, 2005, which is herein incorporated as though set out in full.

NOW, THEREFORE, the parties agree to modify the subject Agreement as follows:

1. Article 3, Funding and Method of Payment, is revised, in part, as follows:

a. Subarticle D., <u>Quarterly Payments</u>, is revised, in part, to change item (i) as follows: "(i) the supporting quarterly reporting statistics, annually developed by MTC and the TAC as described in *Attachment A, Scope of Work, Program Planning*, Task 2.c.

b. Subarticle H., <u>Good Faith Efforts</u>, is revised, in part, to change the first sentence as follows: "Notwithstanding the provisions of this Article 3, payment shall not be made until MTC has determined that RECIPIENT is on track to achieve, or is making a good-faith effort to achieve, the targets set annually by MTC and the TAC."

#### 2. ATTACHMENT A: SCOPE OF WORK, is revised, in part, as follows:

- A. Task 6 under "Employer Outreach" is revised as follows: "Work with the RRP Contractor and the RRP TAC to develop employer outreach measurement strategies and\_consistently measure the outcomes of employer outreach efforts."
- B. Task 2 under "Program Planning" is revised, in part, to add an item e. as follows:
   "e. Establishment of annual performance measures, targets and measurement definitions."
- C. Task 9 under "Program Planning" is revised as follows: "Strive to achieve the annual performance targets established by MTC and the TAC under Task 2.c and documented in the Annual Performance Targets Memo provided by MTC prior to July 1<sup>st</sup> of each fiscal year. Report progress toward meeting the targets on a quarterly basis by the 10th of the month following the end of the quarter."

D. Task 10 under "Program Planning" is deleted.

3. ATTACHMENT C: QUARTERLY STATISTICS FORMAT is deleted in its entirety.

4. <u>Retention of Contract Provisions</u>. Except as otherwise provided herein, all other terms and conditions of the agreement entered into as of June 30, 2005 remain unchanged and are herein incorporated by this reference as though set forth in full.

#### Update:

All twenty citics plus the County in San Mateo County are the first group in the Bay Area to make use of State legislation allowing cities and counties to form a sub-region to plan how to accommodate State requirements to develop housing for population growth. These twenty-one jurisdictions represent one-fifth of the total jurisdictions in the Bay Area Region. The City/County Association of Governments (C/CAG) has been selected as the entity to manage the process for the San Mateo County Sub-region. Over the next 18 months C/CAG, together with the cities and the County, will work to find the best way to ensure that each jurisdiction does the most it can to address the housing crisis facing the Bay Area.

The RHNA Technical Advisory Committee (TAC) representatives have been appointed. C/CAG hosted RHNA TAC meetings on 10/25/06 and 11/30/06. Another TAC meeting is scheduled for 12/14/06. Bylaws were established and approved. The primary effort is focused on relining the Draft Sub-Regional Methodology for determining housing shares. A draft must be submitted to the Association of Bay Area Governments (ABAG) by 12/31/06 with the final document after public hearings for the end of March 2007. The RHNA Policy Advisory Committee (PAC) has not been formed since the Councils and Board of Supervisors will not complete their reorganizations until December. Therefore, only some of the PAC representatives have been appointed. Given this it is not practical to have a December RHNA PAC meeting. Therefore, the Draft Sub-Regional Methodology will be approved by the RIINA TAC and distributed to the City Managers and the PAC members appointed for comments prior to submittal to ABAG. The transmittal letter will clearly emphasize the draft nature and that it has not been approved the RHNA PAC.

#### **RECOMMENDATION**

That the C/CAG Board approve Resolution 06-43 authorizing the C/CAG Chair to execute an amendment to the agreement with Advocation, Inc. to provide Lobbying services during the 2007 Legislative Session for an amount of \$72,000.

#### FISCAL IMPACT

The cost of the outside lobbyist for 2007 will not exceed \$72,000 (including monthly retainer and expenses). This amount is the same as the amount paid to Advocation during 2006. The \$72,000 is programmed in the FY 2006-07 C/CAG budget.

#### SOURCE OF FUNDS

The source of the funds for the lobbyist will be from Congestion Management and National Pollutant Discharge Elimination System (NPDES) revenues.

#### BACKGROUND/DISCUSSION

Since November 2002 C/CAG has had a Legislative Committee. A State Legislative Lobbyist was retained for the 2003 thru 2006 Legislative sessions. C/CAG contracted with Advocation, Inc. for these services. Thirteen (13) bills were Chartered during the 2006 legislative session, of which four (4) were opposed by C/CAG. Propositions 1A, 1B and AB 2538 were approved which will result in significant funds for C/CAG. Advocation was active in representing C/CAG's position on these bills.

It is recommended that the C/CAG Board continue C/CAG's efforts to impact State Legislation by renewing the agreement with Advocation, Inc. for the 2007 Legislative Session at an added cost of \$72,000. The amount represents no change from the current annual amount. This recommendation was based on an evaluation of C/CAG's Legislative Program and the performance of Advocation as the C/CAG Lobbyist during the 2006 Legislative Session.

The Legislative Committee recommended approval, in concept, at the November meeting. This action is the Resolution approving execution of the contract with Advocation, Inc.

#### C/CAG PROCUREMENT POLICY

The C/CAG Procurement Policy allows for an initial contract for consulting services to continue for up to three years, with an extension of an additional three years if desired. This amendment is consistent with these time frames. Next year, C/CAG will prepare a Request for Proposal (RFP) in accordance with board policies.

### **Recommendation:**

Update on the status of issues regarding the Abandoned Vehicle Abatement Program and to provide direction to C/CAG Staff.

### Fiscal Impact:

None. Potential impact to Cities and County participating in the program.

### **Revenue Source:**

Department of Motor Vehicle Fees that are provided to the County for Abandoned Vehicle Abatement.

### Background/Discussion:

C/CAG acts as the San Mateo County AVA Service Authority. The objective of the program is the abatement of abandoned vehicles. Reimbursement is provided to the agencies through revenues provided from vehicle registration fees. The revenues are disbursed to participating agencies 50% based on population and 50% based on the proportionate share of the abatements in the County. If a participating agency does not perform any abatements then that agency's population share is returned to the State. The participating agencies are paid for the number of vehicles that are abated not the vehicles destroyed. Of the vehicles abated less than five per cent are destroyed. This is the approach used by most counties.

### Issue:

As a result of an inquiry from a city in Orange County the California Highway Patrol (CHP) has made a ruling that participating agencies can only be reimbursed for those vehicles destroyed. C/CAG Legal Counsel has reviewed the law and determined that the language of the law is subject to interpretation and can be seen to justify either position. Currently most if not all participating agencies are paid for the number of vehicles that are abated not the vehicles

destroyed. The program has been run in this manner for 11 years. This clearly runs counter to the CHP ruling. Therefore, it raises the following issues.

1- If the CHP ruling stands or is mandated should the program be continued?

Given the low number of vehicles that are destroyed, if the CHP ruling stands or is mandatory then San Mateo County should consider eliminating the program.

2- Should the AVA Program do any further distributions until this is resolved?

If distributions are continued then there is a small likely-hood that funds would have to be returned. The alternative is to halt all distributions to the Cities and the County until the issue is resolved at CHP or through legislation. Funds distributed are \$600K per year. This would most likely impact three to four quarters of distribution (\$450-600K).

3- What actions can be taken to address the issue?

The issues probably should be addressed by working with CHP and in parallel drafting legislation to make it clear that payments for abatements only are allowed.

C/CAG staff feels it is premature to cancel the program as suggested in 1. C/CAG staff requests that the Board authorize the C/CAG staff to pursue actions to address the issue as discussed in 3 including assigning this as a priority for Advocation. The main question is whether or not to continue the distributions to the participating agencies as discussed in 2. C/CAG staff would request direction on the issue in 2. The C/CAG staff recommendation at this time is to pursue 2 and 3.

### **RECOMMENDATION**

That the C/CAG Board receive an update on the San Mateo County nomination of projects submitted to the Metropolitan Transportation Commission (MTC) for funding consideration in the Corridor Mobility Improvement Account (CMIA) of the transportation infrastructure bond.

### FISCAL IMPACT

Funding for the Corridor Mobility Improvement Account (CMIA) will be from the Transportation Infrastructure Bond (Proposition 1B), officially titled "Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006", approved by voters on November 7, 2006.

### SOURCE OF FUNDS

The \$19.9 billion Transportation Infrastructure Bond, approved by voters on November 7, 2006, includes \$4.5 billion for the Corridor Mobility Improvement Account (CMIA) program.

### BACKGROUND/DISCUSSION

Project selection for the \$4.5 billion Corridor Mobility Improvement Account (CMIA) program will primarily be at the California Transportation Commission's (CTC) discretion. This program is for improvements on the state highway system to relief congestion relief. There will be no county minimum or guarantee. Deadline for Congestion Management Agencies (CMA) in the Bay Area to submit project nominations to the MTC was December 1, 2006.

Competitive candidate projects for the CMIA will be those that can demonstrate measurable improvements in congestion relief, safety, connectivity, and air quality. Candidate projects must have documentations such as a Project Study Report that include delivery schedule with construction to begin no later than year 2012.

At the November 9, 2006 meeting, C/CAG Board of Directors approved a list of candidate projects and authorized the C/CAG Executive Director to work with the Metropolitan Transportation Commission (MTC) and Caltrans to make final selection from the candidate project list to be submitted for funding consideration in the Corridor Mobility Improvement Account (CMIA). The C/CAG Executive Director has worked with the San Mateo County Transportation Authority (SMCTA), MTC, and Caltrans and submitted the final nomination project package to the MTC on December 1, 2006.

The final nomination projects are consistent with the list of projects approved by the C/CAG Board on November 9, 2006, with the following two exceptions:

- 1. The US 101 Auxiliary Lanes from 3<sup>rd</sup> Ave to Millbrac Ave: This project was originally fully funded. However, on November 28, 2006, the contract bid was opened. The contractor's bid is in an amount that exceeds the engineer's estimate. Hence, an additional \$30 million is needed if the contract is to be awarded.
- 2. Calera Parkway widening (Highway 1): This project was not originally on the list due to that the project is not on the MTC high priority corridor. However, the amount of funding needed for this project is relatively small. And this project has a completed Project Study Report and can be delivered if funding is provided.

1. What expertise/experience do you have pertaining to serving on this committee? By training and profession, I am a transportation planner, although I am currently not in a paid position. ### **Background:**

The US 101 Auxiliary Lane from Third Avenue to Millbrae Avenue Project is the top priority for San Mateo County. The project bid opening was on 11/28/06. One bid was received. The cost is \$40M over the consultants estimate. Caltrans is reviewing the bid to determine whether to accept it or to modify and rebid. The agreement is to split the cost overrun in the same proportion as the project which is 51% Local Funds and 49% State Funds. This would require the California Transportation Commission to advance \$20M in STIP funds to award the contract, which would come from the STIP County share. This possibly would come from the STIP Augmentation in the Infrastructure Bond. The C/CAG Board has an adopted policy to match the Local Sales Tax Funds in accordance with the Measure A Strategic Plan. Therefore, in the event it is decided to award the contract it may be necessary to advance \$20M in State Transportation Improvement Program Funds.

It is requested that the C/CAG Board authorize the Executive Director to work with the Transportation Authority, Caltrans, and the California Transportation Commission (CTC) staffs to move the project to construction and if necessary to authorize an advance of \$20M in STIP funds.
