




### SM 101 EXPRESS LANES PROJECT THE PROBLEM



### The congestion on 101 will grow worse.

Jobs, housing and population continues to grow!



Without the project, there is no incentive to share a ride and cars will avoid the freeway, clogging local city streets







**BIG PICTURE** 

The Caltrain Electrification Project will not fully address projected demand

The problem is greater than one project can solve.

SamTrans is studying regional express bus service on the 101 corridor

MTC is planning to improve and increase park-and-ride lots

Municipalities implementing TDM measures

SFCTA is coordinating with San Mateo to study an extension of the 101 Express Lanes into San Francisco

VTA is creating an Express Lanes network in Santa Clara County

Construction of the 101 Express Lanes from the San Mateo County line to SR-237 has begun







- **PROJECT PURPOSE**
- Encourage carpooling and transit use.
- Improve travel-time reliability for HOV/express lane users.
- Increase person throughput (number of people moved)
- Apply technology and/or design features to help manage traffic.
- Reduce congestion in the corridor.
- Minimize operational degradation of the general purpose lanes.

**PROJECT FEATURES** 



- HOV lanes will be converted to express lanes from the Santa Clara County line to Whipple Avenue.
- An additional lane in each direction will be created from Whipple Avenue to I-380.
- Safety lighting and overhead tolling signage will be added throughout the corridor.
- No homes/businesses are being purchased.

### **Express Lanes with Converted and Replaced Auxiliary Lanes**












### WHAT IS AN **EXPRESS LANE?**

- Dynamic tolls (congestion pricing) keep lane free flowing





#### MINIMUM ELIGIBILITY CRITERIA

- The proposed US 101 toll facility meets the requirements of Streets and Highways Code Section 149.7
  - The proposed toll facility will improve the corridor's performance.
  - The project is contained in the RTIP, a conforming regional transportation plan, prepared pursuant to Section 65080 of the Government Code.



### MINIMUM ELIGIBILITY CRITERIA

- Caltrans, SMCTA and C/CAG have cooperated extensively on development of the project.
- A Supplemental Project Study Report/Project
   Development Support was approved on June 3,
   2016. The PSR/PDS serves as the Project Initiation
   Document for the Project.
- The Plans, Specifications and Estimate and a Concept of Operations are being developed for the project.

- Increase vehicle and person throughput in the corridor.


