


San Mateo County Growth

Projections:

- Population expected to grow to over 900,000 people by 2040
 - 26% increase between 2010 and 2040
- Population age 65 and over expected to grow by 137% in same time frame
- Thousands of new housing units being built, many geared towards public transit riders
 - New state laws streamlining Transit Oriented Development (TOD)
 - New state laws allowing for Accessory Dwelling Unit (ADU) with no parking requirements if near transit hubs
- Transportation systems are aging
- Some of the worst traffic in the country










The Cost of Doing Business

- Caltrain Operations/SOGR ~ \$20m/year
- SamTrans Operations/SOGR ~ \$25m/year
- Dumbarton Hwy/Rail ~ \$2b+ (total cost)
- CalMod 2.0 ~ \$400m (total SMC cost)
- US 101 Managed Lanes ~ \$500m (total cost)
- US 101/92 Interchange ~ \$16m-\$160m (total cost)
- Senior and Youth Mobility Plans Recommendations ~ \$TBD
- Local Streets and Roads ~ \$TBD
- Bike/Ped ~ \$TBD
- Express Bus Service ~ \$TBD
- Coastside Transit Study Recommendations ~ \$TBD
- Electric Bus Fleet Conversion ~ \$TBD
- Grade Separations ~ \$TBD
- Expanded Ferry Service ~ \$TBD





Enabling Legislation

- AB 1613 (Mullin)
 - Allows ½-cent sales tax
 - \$80 million/year
 - 10 years ~ \$800 million
 - 30 years ~ \$2.4 billion
 - Approval from SamTrans Board and County Board of Supervisors
 - 2/3 approval from county voters
- November 2018 Election
- County of San Mateo Poll (May 2017)

- Process
 - Identify Goals

 - SamTrans Board puts measure on ballot with concurrence of San Mateo County BOS










The Final Expenditure Plan
