## RECOMMENDATION

### FISCAL IMPACT

This agreement allows C/CAG to receive up to \$318,808 from PG&E for the calendar year 2019 program cycle.

## SOURCE OF FUNDS

Funding for the San Mateo County Energy Watch is provided by the PG&E Local Government Partnership.

## BACKGROUND

The San Mateo County Energy Watch (SMCEW) Local Government Partnership (LGP) with PG&E began on January 1, 2009, using Public Goods Funds under the auspices of the California Public Utilities Commission (CPUC). Since the original program cycle, which ended on December 31, 2009, PG&E has contracted with C/CAG for the SMCEW for four additional program cycles, 2010-2012, 2013-2014, 2015, and the current 2016-18 program cycle, which ends on December 31, 2018.

The CPUC and PG&E had intended to begin a new "rolling" program cycle for eight years beginning in 2019. Though many CPUC decisions on the longer program cycle have been adopted, the CPUC is still responding to comments, and PG&E is still preparing for that program transition, which is expected to begin in 2020. Therefore, calendar year 2019 is considered a transition year for the program.

The calendar year 2019 budget of \$318,808 provided to C/CAG by PG&E represents a 54% decrease compared to the annual budget for the 2016-18 calendar year cycle. This reduction is due to new CPUC and associated PG&E decisions, causing a shift of use of Public Goods Funds to what they perceive to be a more cost-effective portfolio.

Staff continues to work regionally with other Local Government Partnerships to find solutions in response to the large reduction in funding proposed by PG&E for the program. There remain some

open questions about procedure since the CPUC has not yet officially approved the PG&E calendar 2019 budget for local government partnership. However, the CWA for the San Mateo County Program expires on December 31, 2018. Hence, the execution of the 2019 CWA is needed to continue the program.

Management and staffing for the SMCEW is provided by the County of San Mateo, under a separate staffing agreement between C/CAG and the County.

Resolution No. 18-61 and the Contract Work Authorization document are included as attachments to this staff report. It is recommended that the C/CAG Executive Director be authorized to negotiate final terms, subject to C/CAG legal counsel approval, prior to execution by the C/CAG Chair.

#### BACKGROUND

On September 16, 2010 the C/CAG Board adopted Resolution 10-53 authorizing the C/CAG Chair to execute an agreement with the BAAQMD to receive a \$50,000 grant, launching the C/CAG Climate Action Plan Template and Tool project. On March 7, 2011, the C/CAG Board adopted Resolution No. 11-11 for a PG&E Contract Work Authorization No. 2500458103 between C/CAG and PG&E for \$125,000. The total grant funding for Climate Action Plan Template was \$175,000, and with C/CAG's commitment to match funds, the total project budget was \$350,000 through calendar year 2012. The project eventually came to be known as the Regionally Integrated Climate Action Planning Suite (RICAPS).

C/CAG began contracting with the County of San Mateo to provide staff services for RICAPS for \$60,000 in 2012, \$50,000 in 2013, and subsequently every year through 2018 in an annual amount of \$40,000. The current agreement for staff services for the RICPAS project end December 31, 2018. The County is requesting additional funding for calendar year 2019 due to the reduction in funding from PG&E for these types of services to cities. The funds for staff services come from Congestion Relief

Funds, serving as a match to the PG&E Local Government Partnership grant. Since climate action planning support is given for all sectors of emissions: energy, transportation, solid waste and other emissions, PG&E has asked that C/CAG provide additional funding for emissions outside of those that are energy-related, such as transportation, tied to development of climate action plans for cities in San Mateo County. The goal of RICAPS is for every city in San Mateo County and the County to have adopted plans to reduce greenhouse gas emissions, a means to track individual jurisdiction and countywide progress, and to provide ongoing implementation and technical support.

Require that all new development within an airport defined over flight zone provide deed notices disclosing airport over flights and noise upon transfer of title to residents and property owners comply with the real estate disclosure requirements of state law. Section 11010 of the Business and Professions Code requires people offering subdivided property for sale or lease to disclose the presence of all existing and planned airports within two miles of the property (Cal. Bus. and Prof. Code Section 110010(b)(13). The law requires that, if the property is within an "airport influence area" designated by the airport land use commission, the following statement must be included in the notice of intention to offer the property for sale:

#### **Notice of Airport in Vicinity**

This property is presently located in the vicinity of an airport, within what is known as an airport influence area. For that reason, the property may be subject to some of the annoyances or inconveniences associated with proximity to airport operations (for example: noise, vibration, or odors). Individual sensitivities to those annoyances can vary from person to person. You may wish to consider what airport annoyances, if any, are associated with the property before you complete your purchase and determine whether they are acceptable to you.

b. CS-8.3 Airport Land Use Commission Review Ensure all applicable plans, ordinances, and development applications are reviewed by the City/County Association of Governments <u>Board of Directors, acting as the for</u> San Mateo County<sup>2</sup>s Airport Land Use Commission, <u>for a determination of</u> <u>consistency with the most current Airport Land Use Compatibility Plan for the</u> <u>Environs of San Francisco International Airport</u>, as required by State law.

- 2. Add two new policies to the Community Safety Element Noise Section:
  - b. A policy to require that all future land use actions and/or associated development conforms to the relevant height, aircraft noise, and safety policies and compatibility criteria contained in the most recently adopted version of the Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport.
- 3. Amend Policy CS-5.4 to reflect adherence to the requirements of SFO ALUCP Policy AP-4 Other Flight Hazards.

## BACKGROUND

The City of Burlingame has recently completed a draft General Plan update. Since the entire city is located within Airport Influence Area (AIA) B for San Francisco International Airport, the area subject to formal CCAG/ALUC review, consistent with the requirements of California Public Utilities Code Section 21676(b), the City of Burlingame has referred its General Plan Update to C/CAG, acting as the San Mateo County Airport Land Use Commission, for a determination of consistency with the SFO ALUCP.

## DISCUSSION

## SFO ALUCP Consistency Evaluation

The SFO ALUCP includes policies regarding establishment of: A) an Airport Influence Area, with related real estate disclosure requirements and Airport Land Use Commission review authority; B) noise compatibility policies and criteria; C) safety policies and criteria; and D) airspace protection policies. The following sections briefly summarize these policies and describe how the Burlingame General Plan addresses each.

A) <u>Airport Influence Area</u> – The SFO ALUCP contains policies related to two Airport Influence Areas (AIAs), Area A and Area B. AIA A identifies an area where real estate disclosure requirements exist to identify proximity to SFO and potential annoyances or inconveniences that may result. AIA B is the project referral area, requiring formal action by the Airport Land Use Commission.

## The draft Burlingame General Plan includes the following related policies:

## CS-4.9: Airport Disclosure Notices

Require that all new development within an airport-defined over-flight zone provide deed notices disclosing airport over-flights and noise upon transfer of title to residents and property owners."

## ➤ CS-8.3: Airport Land Use Commission Review

CCAG/ALUC staff, in consultation with SFO Planning staff and City of Burlingame staff, recommends the following language edits (shown in double underline/strikeout) to these draft policies to more clearly reflect the policies of the SFO ALUCP:

CS-4.9: Airport Disclosure Notices (Revised)

Require that all new development within an airport defined over-flight zone provide deed notices disclosing airport over-flights and noise upon transfer of title to residents and property owners comply with the real estate disclosure requirements of state law. Section 11010 of the Business and Professions Code requires people offering subdivided property for sale or lease to disclose the presence of all existing and planned airports within two miles of the property (Cal. Bus. and Prof. Code Section 110010(b)(13). The law requires that, if the property is within an "airport influence area" designated by the airport land use commission, the following statement must be included in the notice of intention to offer the property for sale:

This property is presently located in the vicinity of an airport, within what is known as an airport influence area. For that reason, the property may be subject to some of the annoyances or inconveniences associated with proximity to airport operations (for example: noise, vibration, or odors). You may wish to consider what airport annoyances, if any, are associated with the property before you complete your purchase and determine whether they are acceptable to you.

CS-8.3 Airport Land Use Commission Review (Revised)

Ensure all applicable plans, ordinances, and development applications are reviewed by the City/County Association of Governments <u>Board of Directors, acting as the for</u>-San Mateo County's Airport Land Use Commission, for a determination of consistency with the most current Airport Land Use Compatibility Plan for the Environs of San Francisco International <u>Airport</u>, as required by State law.

**B)** <u>Noise Policy Consistency Analysis</u> – The SFO ALUCP contains Noise Compatibility Policies, which establish noise compatibility zones (defined by the CNEL 65, 70 and 75 dB contours), define land use compatibility criteria within these zones, and determine circumstances where the granting of an avigation easement is required.

## The draft Burlingame General Plan includes the following airport noise related policies:

## ➤ CS-4.7: Airport and Heliport Noise

Monitor noise impacts from aircraft operations at San Francisco International Airport and Mills-Peninsula Medical Center, and implement applicable noise abatement policies and procedures as outlined in the Airport Noise Ordinance and Airport Land Use Compatibility Plan. ➤ CS-4.8: Airport Noise Evaluation and Mitigation

Require project applicants to evaluate potential airport noise impacts if the project is located within the 60 CNEL contour line of San Francisco International Airport (as mapped in the Airport Land Use Compatibility Plan). All projects shall be required to mitigate impacts to comply with the interior and exterior noise standards established by the Airport Land Use Compatibility Plan

Add a new policy to the Community Safety Element Noise Section to reflect the requirements of SFO ALUCP Policy NP-3 Grant of Avigation Easement, specifically acknowledging the applicability, timing and content of an avigation easement.

C) <u>Safety Policy Consistency Analysis</u> – The SFO ALUCP includes five sets of safety zones and sets forth compatibility criteria for each of these zones. As shown on Attachment 4, portions of Burlingame lie within Safety Zones 2, 3 and 4.

# The draft Burlingame General Plan contains the following policy broadly addressing both safety and air space protection:

CS-8.1: Land Use Safety Compatibility and Airspace Protection Criteria Consider all applicable Federal statutes (including 49 U.S.C. 47107), Federal regulations (including 14 Code of Federal Regulations 77 et seq.), the Federal Aviation Administration (FAA) Airport Compliance Manual, FAA Advisory Circulars, other forms of written guidance, and State law with respect to criteria related to land use safety and airspace protection when evaluating development applications within the Airport Influence Area of the San Francisco International Airport and Mill-Peninsula Medical Center helipad.

D) <u>Airspace Protection Policy Consistency Analysis</u> – 14 Code of Federal Regulations (CFR) Part 77, Safe, Efficient Use and Preservation of the Navigable Airspace, governs the FAA's review of proposed construction exceeding certain height limits, defines airspace obstruction criteria, and provides for FAA aeronautical studies of proposed construction. Airspace Protection policies in the SFO ALUCP require compliance with these requirements.

As noted above, the draft Burlingame General Plan includes Policy CS-8.1, which specifically cites these requirements.

The SFO ALUCP also contains an additional policy to reflect the need to review land uses with specific characteristics that might affect aircraft operations.

## AP-4 OTHER FLIGHT HAZARDS ARE INCOMPATIBLE

Proposed land uses with characteristics that may cause visual, electronic, or wildlife hazards, particularly bird strike hazards, to aircraft taking off or landing at the Airport or in flight are incompatible in Area B of the Airport Influence Area. They may be permitted only if the

uses are consistent with FAA rules and regulations. Proof of consistency with FAA rules and regulations and with any performance standards cited below must be provided to the Airport Land Use Commission (C/CAG Board) by the sponsor of the proposed land use action. Specific characteristics that may create hazards to aircraft in flight and which are incompatible include...

(f) Any use that creates an increased attraction for wildlife, particularly large flocks of birds, that is inconsistent with FAA rules and regulations, including, but not limited to, FAA Order 5200.5A, *Waste Disposal Sites On or Near Airports*, FAA Advisory Circular 150.5200-33B, *Hazardous Wildlife Attractants On or Near Airports*, and any successor or replacement orders or advisory circulars. Exceptions to this policy are acceptable for wetlands or other environmental mitigation projects required by ordinance, statute, court order, or Record of Decision issued by a federal agency under the National Environmental Policy Act.

# The draft Burlingame General Plan contains the following policy, that as written may conflict with policy AP-4.

▶ Policy CS-5.4: Wetland Buffer

Identify setback areas and parklands suitable for creation of a wetland buffer, and require new developments in the Bayfront area to assist in restoring wetlands areas.

Because wetlands are likely to attract wildlife, it is recommended that Policy CS-5.4 be amended to reflect the additional need to comply with the requirements of SFO ALUCP Policy AP-4 Other Flight Hazards.

## Airport Land Use Committee Meeting

The Airport Land Use Committee considered this item at its October 25, 2018 meeting, and voted unanimously to find the project conditionally compatible with the SFO ALUCP, subject to the recommended conditions outlined in the staff report, as well as an additional condition clarifying that Burlingame will comply with all noise, safety and airspace protection policies outlined in the most current ALUCP for SFO.

## RESOLUTION OF THE BOARD OF DIRECTORS OF THE CITY/COUNTY ASSOCIATION OF GOVERNMENTS OF SAN MATEO COUNTY, ACTING AS THE SAN MATEO COUNTY AIRPORT LAND USE COMMISSION, DETERMINING THAT THE CITY OF BURLINGAME GENERAL PLAN UPDATE IS CONDITIONALLY CONSISTENT WITH THE COMPREHENSIVE AIRPORT LAND USE COMPATIBILITY PLAN FOR THE ENVIRONS OF SAN FRANCISCO INTERNATIONAL AIRPORT

**RESOLVED**, by the Board of Directors of the City/County Association of Governments of San Mateo County (C/CAG), acting as the San Mateo County Airport Land Use Commission (ALUC); that,

**WHEREAS,** California Public Utilities Code Section 21676(b) requires that prior to the amendment of a general plan or specific plan, or the adoption or approval of a zoning ordinance, a local agency shall first refer the proposed action to the Airport Land Use Commission for a determination of consistency with the applicable Airport Land Use Plan; and,

WHEREAS, the City of Burlingame has submitted its General Plan update to C/CAG, acting as the San Mateo County Airport Land Use Commission, for a determination of consistency with the Comprehensive Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport (SFO ALUCP); and

**WHEREAS**, the entire City of Burlingame is located within Area B of the Airport Influence Area (AIA) for San Francisco International Airport, the area subject to formal CCAG/ALUC Review; and

WHEREAS, the SFO ALUCP four sets of airport/land use compatibility policies and criteria in the SFO ALUCP relate to the content of the Burlingame General Plan update: (a) defining Airport Influence Areas, with related real estate disclosure requirements and Airport Land Use Commission review authority; (b) aircraft noise impacts; (c) safety compatibility criteria; and (d) height of structures/airspace protection, as discussed below:

(a) <u>Airport Influence Area</u> – The SFO ALUCP contains policies related to two Airport Influence Areas (AIAs), Area A and Area B. AIA A identifies an area where real estate disclosure requirements exist to identify proximity to SFO and potential annoyances or inconveniences that may result. AIA B is the project referral area, requiring formal action by the Airport Land Use Commission.

The draft Burlingame General Plan includes the following related policies:

CS-4.9: Airport Disclosure Notices

Require that all new development within an airport-defined over-flight zone provide deed notices disclosing airport over-flights and noise upon transfer of title to residents and property owners."

CS-8.3: Airport Land Use Commission Review Ensure all applicable plans, ordinances, and development applications are reviewed by the City/County Association of Governments for San Mateo County's Airport Land Use Commission, as required by State law." Subject to language edits to these two policies outlined in Exhibit A, which add clarity to the real estate disclosure requirements and Airport Land Use Commission Review authority and process, the draft Burlingame General Plan would be consistent with the SFO ALUCP Airport Influence Area Policies.

(b) <u>Noise Policy Consistency Analysis</u> – The SFO ALUCP contains Noise Compatibility Policies, which establish noise compatibility zones (defined by the CNEL 65, 70 and 75 dB contours), define land use compatibility criteria within these zones, and determine circumstances where the granting of an avigation easement is required.

The draft Burlingame General Plan includes the following airport noise related policies:

### CS-4.7: Airport and Heliport Noise

Monitor noise impacts from aircraft operations at San Francisco International Airport and Mills-Peninsula Medical Center, and implement applicable noise abatement policies and procedures as outlined in the Airport Noise Ordinance and Airport Land Use Compatibility Plan.

CS-4.8: Airport Noise Evaluation and Mitigation

Require project applicants to evaluate potential airport noise impacts if the project is located within the 60 CNEL contour line of San Francisco International Airport (as mapped in the Airport Land Use Compatibility Plan). All projects shall be required to mitigate impacts to comply with the interior and exterior noise standards established by the Airport Land Use Compatibility Plan

Subject to these policies and the addition of a new policy to reflect the requirements of SFO ALUCP Policy NP-3 Grant of Avigation Easement, the draft Burlingame General Plan would be consistent with the SFO ALUCP Noise Policies.

(c) <u>Safety Policy Consistency Analysis</u> – The SFO ALUCP includes five sets of safety zones and sets forth compatibility criteria for each of these zones.

The draft Burlingame General Plan contains the following policy broadly addressing both safety and air space protection:

CS-8.1: Land Use Safety Compatibility and Airspace Protection Criteria Consider all applicable Federal statutes (including 49 U.S.C. 47107), Federal regulations (including 14 Code of Federal Regulations 77 et seq.), the Federal Aviation Administration (FAA) Airport Compliance Manual, FAA Advisory Circulars, other forms of written guidance, and State law with respect to criteria related to land use safety and airspace protection when evaluating development applications within the Airport Influence Area of the San Francisco International Airport and Mill-Peninsula Medical Center helipad.

Subject to this policy and the addition of a new policy to require that all future land use actions and/or associated development conforms to the relevant height, aircraft noise, and safety policies and compatibility criteria contained in the most recently adopted version of the Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport, the draft Burlingame General Plan would be consistent with the SFO ALUCP Safety Policies.

(d) <u>Airspace Protection Policy Consistency Analysis</u> – 14 Code of Federal Regulations (CFR) Part 77, *Safe, Efficient Use and Preservation of the Navigable Airspace*, governs the FAA's review of proposed construction exceeding certain height limits, defines airspace obstruction criteria, and provides for FAA aeronautical studies of proposed construction. Airspace Protection policies in the SFO ALUCP require compliance with these requirements.

As noted above, the draft Burlingame General Plan includes Policy CS-8.1, which cites these requirements.

In addition, the SFO ALUCP also contains Policy AP-4 Other Flight Hazards, addressing, among others, uses that create an increased attraction for wildlife, particularly large flocks of birds, which might affect aircraft operations.

The draft Burlingame General Plan contains the following policy, that as written may conflict with policy AP-4.

Policy CS-5.4: Wetland Buffer Identify setback areas and parklands suitable for creation of a wetland buffer, and require new developments in the Bayfront area to assist in restoring wetlands areas.

Because wetlands are likely to attract wildlife, Policy CS-5.4 is to be amended to reflect the additional need to comply with the requirements of SFO ALUCP Policy AP-4 Other Flight Hazards. Subject to this modification, and the addition of the new policy noted in section (c) above, the draft Burlingame General Plan would be consistent with the Airspace Protection Policies of the SFO ALUCP.

WHEREAS, at their October 25, 2018 meeting, and based on the factors and conditions listed above, the Airport Land Use Committee recommended that the C/CAG Board of Directors, acting as the Airport Land Use Commission, determine that the Burlingame General Plan Update is consistent with the applicable provisions of the SFO ALUCP; and,

**NOW THEREFORE BE IT RESOLVED**, by the Board of Directors of the City/County Association of Governments of San Mateo County, acting as the San Mateo County Airport Land Use Commission, that subject to the conditions in Exhibit A, attached, the Burlingame General Plan Update is determined to be consistent with the Comprehensive Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport.

### **Resolution 18-63 – Conditions of Approval:**

# 1. Amend language of the following draft Burlingame General Plan Policies, as shown in double underline/strikeout:

a. CS-4.9: Airport Disclosure Notices

Require that all new development within an airport defined over flight zone provide deed notices disclosing airport over flights and noise upon transfer of title to residents and property owners comply with the real estate disclosure requirements of state law. Section 11010 of the Business and Professions Code requires people offering subdivided property for sale or lease to disclose the presence of all existing and planned airports within two miles of the property (Cal. Bus. and Prof. Code Section 110010(b)(13). The law requires that, if the property is within an "airport influence area" designated by the airport land use commission, the following statement must be included in the notice of intention to offer the property for sale:

### **Notice of Airport in Vicinity**

This property is presently located in the vicinity of an airport, within what is known as an airport influence area. For that reason, the property may be subject to some of the annoyances or inconveniences associated with proximity to airport operations (for example: noise, vibration, or odors). Individual sensitivities to those annoyances can vary from person to person. You may wish to consider what airport annoyances, if any, are associated with the property before you complete your purchase and determine whether they are acceptable to you.

b. CS-8.3 Airport Land Use Commission Review

Ensure all applicable plans, ordinances, and development applications are reviewed by the City/County Association of Governments <u>Board of Directors, acting as the for</u>-San Mateo County's Airport Land Use Commission, for a determination of consistency with the most current Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport, as required by State law.

#### 2. Add two new policies to the Community Safety Element Noise Section:

- a. A policy to reflect the requirements of SFO ALUCP Policy NP-3 Grant of Avigation Easement, specifically acknowledging the applicability, timing and content of an avigation easement, and
- b. A policy to require that all future land use actions and/or associated development conforms to the relevant height, aircraft noise, and safety policies and compatibility criteria contained in the most recently adopted version of the Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport.

# 3. Amend Policy CS-5.4 to reflect adherence to the requirements of SFO ALUCP Policy AP-4 Other Flight Hazards.

Require the design of new motels, hotels, nursing homes, hospitals and other similar uses to comply with the following noise standards:

- The maximum acceptable interior noise level for sleeping areas shall be an Ldn of 45 dB with windows closed.
- For project locations that are primarily exposed to aircraft, Caltrain and BART noise, the maximum instantaneous noise level in sleeping areas shall not exceed 50dB(A) at night (10:00 P.M. to 7:00 A.M.) and 55dB(A) during the day (7:00 A.M. to 10:00 P.M.) with windows closed. [DR]

# CS-4.5: Noise Mitigation and Urban Design

Consider the visual impact of noise mitigation measures; require solutions that do not conflict with urban design goals and policies included in the General Plan. [DR]

# CS-4.6: Freeway Sound Walls

Coordinate with Caltrans to ensure new sound walls and landscaping strips are attractive along State Route 101 to protect adjacent areas from excessive freeway noise in conjunction with any new freeway project. [AC]

San Francisco International Airport (Airport) appreciates the opportunity to review and comment on the City of Burlingame's application for Land Use Consistency Determination for Envision Burlingame – Burlingame General Plan Update (Draft, August 2017), submitted to the City/County Association of Governments of San Mateo County (C/CAG) acting in its capacity as the Airport Land Use Commission (ALUC). There are three policies in the Community Safety Element of the General Plan Update that as proposed are inconsistent with the Comprehensive Airport Land Use Compatibility Plan for the Environs of San Francisco International Airport (CALUCP, October 2012).

### **Policy CS-4.9 Airport Disclosure Notices**

Require that all new development within an airport-defined over-flight zone provide deed notices disclosing airport over-flights and noise upon transfer of title to residents and property owners.

The Airport recommends that Policy CS-4-9, to be consistent with Airport Influence Area (AIA) IP-1 Airport Influence Area A – Real Estate Disclosure Area, of the CALUCP, should read:

Require that all new development, the real estate disclosure requirements of state law apply. Section 11010 of the Business and Professions Code requires people offering subdivided property for sale or lease to disclose the presence of all existing and planned airports within two miles of the property (Cal. Bus. And Prof. Code Section 11010(b)(13). The law requires that, if the property is within an "airport influence area" designated by the airport land use commission, the following statement must be included in the notice of intention to offer the property for sale:

### Notice of Airport in Vicinity

This property is presently located in the vicinity of an airport, within what is known as an airport influence areas. For that reason, the property may be subject to some of the annoyances or inconveniences associated with proximity to airport operations (for example: noise, vibration, or odors). Identify setback areas and parklands suitable for creation of a wetland buffer, and require new developments in the Bayfront area to assist in restoring wetlands areas.

Wetlands are attractive to many types of wildlife, including many which rank high on the list of species that pose a hazard to safe aircraft operations at Airports. Locating new wetlands in close proximity to the Airport poses wildlife hazards to arriving and departing aircraft. A policy recommending creation of wetlands would be inconsistent with the CALUCP, AP-4 Other Flight Hazards are Incompatible, which states, "...(f) Any use that creates an increased attraction for wildlife, particularly large flocks of birds, that is inconsistent with FAA rules and regulations, including, but not limited to, FAA Order 5200.5A, *Waste Disposal Sites On or Near Airports*, FAA Advisory Circular 150/5200-33B, *Hazardous Wildlife Attractants On or Near Airports*, and any successor or replacement orders or advisory circulars. Exceptions to this policy are acceptable for wetlands or other environmental mitigation projects required by ordinance, statute, court order, or Record of Decision issued by a federal agency under the National Environmental Policy Act. (CALUCP, Page IV-59, October 2012)

### Policy CS-8.3: Airport Land Use Commission Review

Ensure all applicable plans, ordinances, and development applications are reviewed by the City/County Association of Governments for San Mateo County's Airport Land Use Commission as required by State law.

The Airport recommends that Policy CS-8.3 should be revised to clearly state that the Airport Land Use Commission review is to determine whether the proposed action is consistent or not consistent with the Airport Land Use Compatibility Plan (ALUCP), with the Airport Land Use Commission (C/CAG Board) Consistency Determination Process (CALUCP, GP- 12, page III-15, October 2012).







# BACKGROUND

The Stormwater Committee provides policy and technical advice and recommendations to the C/CAG Board of Directors and direction to technical subcommittees on all matters relating to stormwater management and compliance with associated regulatory mandates from the State Water Resources Control Board and San Francisco Bay Regional Water Quality Control Board. The Stormwater Committee includes a designated seat for each member agency and a non-voting seat for the Regional Water Quality Control Board for a total of 22 members.

The Congestion Management Program Technical Advisory Committee (CMP TAC), provide technical expertise for the Congestion Management and Environmental Quality (CMEQ) Committee and the C/CAG Board. The TAC is made up of engineers and planners from local jurisdictions in addition to one representative each from Caltrans, SMCTA/Peninsula Corridor JPB/Caltrain, MTC, and C/CAG. As approved by the C/CAG Board, the maximum number of TAC members is 25 and the total varies depending on vacancies and/or interest from the city staff. Typically, when a seat becomes vacant on the CMP TAC, C/CAG staff will solicit agencies not represented regarding interest in being added to the committee.

The City of Daly City is requesting the appointment of Richard Chiu, Public Works Director, to replace John Fuller, former Public Works Director who has retired, on the Stormwater Committee and CMP TAC. The appointment will replace a member previously representing the same city.

## SOURCE OF FUNDS

Funding for the San Mateo County Energy Watch is provided by the PG&E Local Government Partnership.

## BACKGROUND

The San Mateo County Energy Watch (SMCEW) Local Government Partnership with PG&E began on January 1, 2009, using Public Goods Funds under the auspices of the California Public Utilities Commission (CPUC). Since the original program cycle, which ended on December 31, 2009, PG&E has contracted with C/CAG for the SMCEW for four additional program cycles, 2010-2012, 2013-2014, 2015, and the current 2016-18 program cycle, which ends on December 31, 2018. C/CAG is in the process of contracting with PG&E for calendar year 2019.

The CPUC began a process for redesigning the use of Public Good Funds in early 2016, with the goal of doubling energy efficiency outcomes and making these efforts more cost effective in California. In the process, the CPUC adopted a decision shifting Public Goods Fund programs from 20% to 60% competitively bid, third-party programs, away from Local Government Partnership and long-term strategic planning program efforts. PG&E's response was to reduce Energy Watch program funding by approximately 50% across PG&E's territory. As a result, the proposed calendar year 2019 program budget is a 54% cut from current (2018) budget.

The CPUC continues to consider changes to Public Goods Fund and Local Government Partnership programs that may affect C/CAG's SMCEW program with PG&E. Participating in these proceedings

requires submitting pleadings on short timeframes, i.e., between C/CAG Board meetings. Accordingly, the C/CAG Executive Director would like the authority to, on behalf of C/CAG, become a party to CPUC proceedings related to the SMCEW, as well as comment on decisions and file letters of support or protests to the filings of other stakeholders in those proceedings. These responses may be filed either individually or jointly with other agencies or stakeholders.

Resolution 18-64, an attachment to this staff report, provides the C/CAG Executive Director authority to respond in support of the San Mateo County Energy Watch Program.

## SOURCE OF FUNDS

Caltrans awarded C/CAG \$986,300 from its SB 1-funded Climate Change Adaptation Planning Grant Program, and C/CAG committed to provide up to \$145,185 in local matching funds from the \$4 vehicle registration fee revenue designated for countywide stormwater pollution prevention projects.

# BACKGROUND

C/CAG was awarded a \$986,300 Adaptation Planning Grant by Caltrans to develop a Countywide Sustainable Streets Master Plan (Master Plan) that prioritizes street segments throughout the county for integrating green stormwater infrastructure with other planned investments and community priorities. The grant program requires a local match of at least 11.47%. The project includes the following key tasks:

- Community Engagement
- Climate Adaptation Risk Analysis on Local Transportation Network
- High-Resolution Data Analysis and Fine-Scale Drainage Delineation
- Prioritization of Sustainable Streets Opportunities and Development of Master Plan
- Project Concepts
- Web-based Sustainable Streets Project Implementation Mapping and Tracking Tool

The project is intended to evaluate climate change impacts to precipitation in terms of managing runoff from the roadway network throughout the county and prioritize opportunities for integrating green stormwater infrastructure with other planned investments to help adapt the roadway network and

downstream infrastructure to these impacts. Other planned investments include member agency plans for bicycle and pedestrian and Safe Routes to School improvements, pavement maintenance and reconstruction, utility replacement, etc. The Master Plan will prioritize the specific roadway segments that make the most sense for integrating green infrastructure in five-, 10-, and 20-year time horizons and will include up to 10 project concepts to help member agencies pursue funding for implementation. The project will take advantage of the County's recently acquired high-resolution aerial surveying data to develop improved drainage mapping throughout the county and a web-based mapping and tracking tool will be created to demonstrate progress over time in managing stormwater runoff and future climate change risks. Although the grant is focused on climate change adaptation, the work products will directly support C/CAG member agencies' Green Infrastructure Planning efforts required under the Municipal Regional Permit.

C/CAG released a Request for Proposals on August 30, 2018 to solicit consultant support for implementing the project. The Request for Proposals was posted on C/CAG's website, emailed out to known interested parties, and advertised through regional and statewide distributions by the Bay Area Stormwater Management Agencies Association and the California Stormwater Quality Association. Staff held a pre-proposal meeting on September 13 that was attended by representatives of four firms.

Proposals were due on September 25 and C/CAG received two proposals: one from Paradigm Environmental (teamed with Lotus Water, Alta Planning + Design, EOA, Urban Rain|Design, Community Design + Architecture, and Northwest Hydraulic Consultants) and one from Tetra Tech. Staff convened a five-person selection committee consisting of representatives from C/CAG, the County Health System, County Office of Sustainability, and the City of Burlingame. The committee reviewed proposals and interviewed both teams. The selection committee evaluated the teams based on the following criteria:

- Overall approach and understanding
- Experience with similar kinds of work
- Cost-effectiveness of proposal and timeline
- Staff qualifications
- Capability of developing innovative or advanced techniques
- Familiarity with state and federal procedures

Based on the combined scoring of proposals and interview results, the selection committee recommended the Paradigm Environmental team and staff checked provided references. On October 18, the C/CAG Stormwater Committee approved a recommendation for the C/CAG Board of Directors to execute a funding agreement with the Paradigm Environmental team.

C/CAG has an executed grant agreement with Caltrans and received a Notice to Proceed on October 1, 2018. The project needs to be completed by the end of February 2021, with all final project reimbursements submitted to Caltrans by April 28, 2021. Staff recommends the C/CAG Board approve Resolution 18-65 (Attachment 1), authorizing the C/CAG Chair to execute a funding agreement in an amount not to exceed \$942,221 with Paradigm Environmental (Attachment 2) and further authorizing the Executive Director to negotiate the final scope and terms of the agreement, subject to approval as to form by C/CAG Legal Counsel.

It is important to note that the Paradigm Environmental proposal is for \$942,221, \$189,264 less than the combined total of the approved Caltrans grant (\$986,300) and C/CAG-committed local matching funds (\$145,185). To take full advantage of the allocated grant funds, staff anticipates coming back to the Board in the future with a proposed contract amendment to allocate additional funds, if needed, to supplement the existing proposed scope of work once staff has a better sense of where additional funds are needed to

augment or supplement an existing task. Examples of where additional funding may be beneficial include expanded community engagement efforts, producing additional project concepts, filling data gaps when compiling countywide datasets for drainage delineation or opportunity prioritization, or increasing functionality of the web-based tracking tool. Any contract amendment would be vetted with Caltrans staff to ensure consistency with the grant program prior to coming to the C/CAG Board for consideration.

WHEREAS, the selection committee evaluated the proposals and the teams based on their overall approach, understanding, and experience with similar kinds of work, cost-effectiveness and timeline, staff qualifications, capability of developing innovative or advanced techniques, and familiarity with state and federal procedures; and

**WHEREAS,** the selection committee recommended a team of consultants led by Paradigm Environmental to develop the Countywide Sustainable Streets Master Plan; and

**WHEREAS**, C/CAG's Stormwater Committee, at its October 18, 2018 meeting, recommended the C/CAG Board execute a funding agreement with Paradigm Environmental;

CDA is developing green infrastructure guidance documents to support C/CAG member agencies in developing their local green infrastructure plans, as required by the Municipal Regional Permit. ## BACKGROUND

The C/CAG Board approved Resolution 17-05 adopting the San Mateo Countywide Transportation Plan 2040 (SMCTP 2040) at the February 9, 2017 meeting and subsequently, at the March 9, 2017 meeting, the Board was provided a list of "next steps" to be performed as follow-up strategies for implementing the SMCTP 2040. At the July 13, 2017, the Board received an update and provided input on follow-up activities for the formation of a Working Group for the implementation phase of the SMCTP 2040.

The key recommendations considered for the follow-up phase of the SMCTP 2040 included:

- Conduct supplemental meetings, public outreach, and engagement with stakeholders;
- Review key recommendations;
- Consider additional input for implementation phase;
- Generate a coordinated action plan;

Because the SMCTP 2040 has been adopted, no modifications or edits to the document were recommended in the Follow-Up Process.

## SMCTP 2040 Follow-Up Working Group Membership

After receiving direction from the Board at the July 13, 2017 meeting, staff convened the SMCTP

2040 Follow-Up Working Group comprised of 20 interested members from the community, advocacy groups, C/CAG Board members, and transportation officials to advise staff how to refine strategies for the SMCTP 2040 Follow-Up Action Plan. The Working Group met a total of five times over the course of the Follow-Up process to provide input on the following:

- Alignment of funding with vision statement established by the SMCTP 2040;
- Consider additional strategies to analyze equity;
- Consider potential performance measures and targets to support goals, vision, and objectives set out by the SMCTP 2040.

# SMCTP 2040 Follow-Up Action Plan

The SMCTP 2040 Follow-Up Action Plan (Action Plan), included as Attachment 1, provides San Mateo County jurisdictions, leaders, and stakeholders a roadmap for implementing and tracking the SMCTP 2040. The Action Plan will serve as a guiding tool for C/CAG and its member agencies to ensure appropriate modifications are discussed during the next CTP update. The Action Plan is intended to be a living document that can be modified, as necessary.

The Action Plan has nine (9) Chapters. The "Action Plan Priorities" chapter discusses actions to improve implementation as it relates to tracking performance measures outlined in the SMCTP 2040, specifically, person throughput, accessibility, and safety. Such performance tracking will be implemented through pilot projects to be developed. For each chapter, a formal list of one to three performance measures were identified to be tracked over time as part of the implementation process. The focused list allows C/CAG staff to track success of the performance measures, make any appropriate modifications, and limit the amount of data needed by member agencies. To track the success of performance measures, C/CAG will rely on data provided by member agencies as part of a Data Request Form (Appendix A of the Action Plan).

# Outreach and On-Going Collaboration with Member Agencies

The Action Plan recommends additional outreach by convening the SMCTP 2040 Implementation Group to provide feedback on the Action Plan's implementation. The group will assist C/CAG by ensuring the appropriate data and performance measures/targets are utilized to ensure performance measures are being met. The group will also assess if and why certain performance measures are not met and will maintain a list of recommended edits and additions to the performance measures.

C/CAG, and the SMCTP 2040 Implementation Group, will proactively communicate with member agencies, particularly regarding Appendix A of the Action Plan: Data Request for Member Agencies. The Action Plan is a living document and modifications can be updated periodically to reflect current best practices, address new technologies, and availability of data from member agencies.

Staff presented the Draft Final SMCTP 2040 Follow-Up Action Plan to the Congestion Management Program Technical Advisory Committee (TAC) on October 18, 2018 and the Congestion Management and Environmental Quality Committee (CMEQ) on October 29, 2018. The TAC approved staff's request to approve the SMCTP 2040 Follow-Up Action Plan with the condition that Appendix A: Data Request for Member Agencies changes to a draft form to ensure collaboration with member agencies on data needs. The CMEQ Committee also recommended approval of the Action Plan, reiterating the need to track progress and performance measures and that future projects be shaped to accomplish the vision and goals identified in the Plan.

Staff recommends the C/CAG Board approve the SMCTP 2040 Follow-Up Action Plan.

# BACKGROUND

At the September 2018 C/CAG Board meeting, the Board received an update on the San Mateo Countywide Water Coordination committee progress. The Board was informed of the Staff Advisory Team's (SAT) effort in the development of a draft proposal for a countywide entity focused on integrated flood resiliency, sea level rise, and regional stormwater management, and to better compete for federal, state, regional, and other funding sources.

The SAT's goal is to prepare a draft new agency proposal by this December, with the approval by the Water Committee, for presentation to the C/CAG Board and the County Board of Supervisors in January 2019.

Since September, after obtaining initial input via outreach to all 20 cities through five informational meetings, and based on the framework and tools developed by SAT with ESA consultant's assistance, a preliminary draft proposal has been prepared. It is currently undergoing review, and will be discussed at two upcoming workshops with city managers and other city representatives, scheduled for November 14<sup>th</sup> at 10 am in Brisbane and December 3<sup>rd</sup> at 9:30 am in San Mateo.

Staff will present some elements of the draft agency proposal at the November 8 C/CAG Board meeting as information.

# BACKGROUND

On October 12, 2018, representatives from the San Francisco County Transportation Authority (SFCTA), C/CAG, and the San Mateo Transportation Authority (SMCTA) visited LA Metro to tour an express lane project that has been in operation since 2012.

The tour included experience traveling on the express lanes, viewing tolling equipment in operations, and visiting the operations and customer service center. The afternoon included a presentation of LA Metro's various incentive programs, enforcement policies, and expansion plans. Officials shared their experience and challenges associated with the initial implementation of their express lanes and described the public support and success of their current operations. There was also a discussion held with Michael Manville, a professor from UCLA who researches transportation equity and congestion pricing.

Below are some highlights from the morning tour and afternoon discussions:

## Morning Tour Highlights

- 1. Constructed the I-110 (14 miles) in 2012 and I-10 (11 miles) in 2013.
- 2. These were not new lanes. These facilities converted high occupancy vehicle into express lanes with entry and exit at designated locations. Some are double express lanes.

- 3. LA Metro runs their express lanes like a business where travel time reliability in the lane is their product. The lanes are operated to maintain level of service, not to maximize revenue.
- 4. After operations and maintenance expenses, there are set asides for transit operations and Caltrans maintenance.
- To date, \$50 mil in grants have been provided to reinvest in the corridors (within 3 a mile radius). These grants included new bus stations, bus station upgrades, bike lockers, and a 1<sup>st</sup>/ last mile bikeshare program.
- 6. LA Metro contracts \$3.3 million annually with CHP for enforcement but are piloting two video occupancy detectors (VOD) at strategic high violation locations. Currently VOD is still just an aid for CHP.
- 7. 42 million trips a year (115,000/day) are taken on the express lanes, 2/3 of which are on the I-110.
- 8. 702,500 toll accounts have been opened since inception and an average of 5,600 are added each month.
- 9. The average AM peak toll prices are \$6.86 on I-110 and \$6.21 on I-10. PM peak toll prices are lower.
- 10. The current maximum price to drive the full express lane length is \$22.50 for the I-110 and \$26.20 for the I-10.

# Afternoon Discussion Highlights

- 1. Metro has several incentive programs in place:
  - a. Transit rewards Customers (account holders) can get credit for travel on buses that use express lanes (even non-METRO buses). After 16 trips customers get \$5 in toll credit. Approximately \$180,000 in credit has been issued to date.
  - b. Carpool Loyalty Program Carpoolers are automatically entered to win a gift card (monthly drawings). One just needs to be a customer. \$45,000 in gift cards were distributed to date.
  - c. Low Income Assistance Program The eligibility criteria is two times the federal poverty rate which they state is similar to that of utility lifeline criteria.
    - i. The program is open to LA County residents
    - ii. Participants receive a \$25 toll credit upon enrollment
    - iii. The \$1/month service fee is waived

There are currently 17,049 low income assistance accounts with approximately 3,000 added a year. 75% of these account holders who use the express lanes are carpoolers and are not paying tolls.

- 2. Future planned programs
  - a. Clean Air Vehicle (CAV) discount program CAVs will be charged a discounted rate.
  - b. Explore issuing toll credits for shifting travel outside of peak period on north bound I-110.
- 3. Professor Manville stated that on the surface there is the common perception that congestion pricing isn't fair and unfairly burdens the poor. However, it is an assumption that the status quo is

fair which is not that obvious when one start to observe effects of congestion on air quality along areas that are normally inhabited by low income residents.

- a. It was cited how congestion pricing might be a fairer way to pay for transportation, as the very low income community tends to be more transit dependent, tends to carpool at higher rates than the wealthy, and tends to travel off peak more.
- b. The low-income community can also benefit from reliable travel options during critical times such as late child care pick up penalties or critical work appointments.
- c. If excess net revenues can be directed to services that the low-income communities use, such as transit, it could provide more choices and help low income communities.
- 4. In August 2018, a customer survey of 81,748 Metro Express Lanes customers was conducted. Surveys were sent to all customers with a valid email on file:
  - a. They received an 89-90% satisfaction rate with system performance in terms of speed and travel time on the express lanes.
  - b. Customers were asked to rank the importance of different ways to mitigate traffic congestion. If they could only choose one thing, 41% of customers believe that expanding Express Lanes onto other corridors would be the best way to mitigate congestion. 37.5% chose local roadway improvements, 12.4% chose transit improvements, and 8.8% chose active transportation improvements.
  - c. When ranking strategies as high or low importance, 75% of customers ranked local roadway improvement and 68% ranked Express Lane expansion as high importance. 33% of customers ranked transit and 24% of customers ranked active transportation improvements (walking and biking) as high importance.
- 5. LA Metro has plans to expand Express Lanes to I-405, I-605, and I-105.
