What is the RTP/SCS?



- ▷ RTP/SCS is a state mandated, long-range transportation, land-use, and housing planning document
- ▷ PBA 2050 will detail how the Bay Area's transportation system will be maintained, improved and expanded to the horizon year of 2050
- ▷ Updated every four (4) years
- ▷ MTC is responsible for developing the RTP/SCS



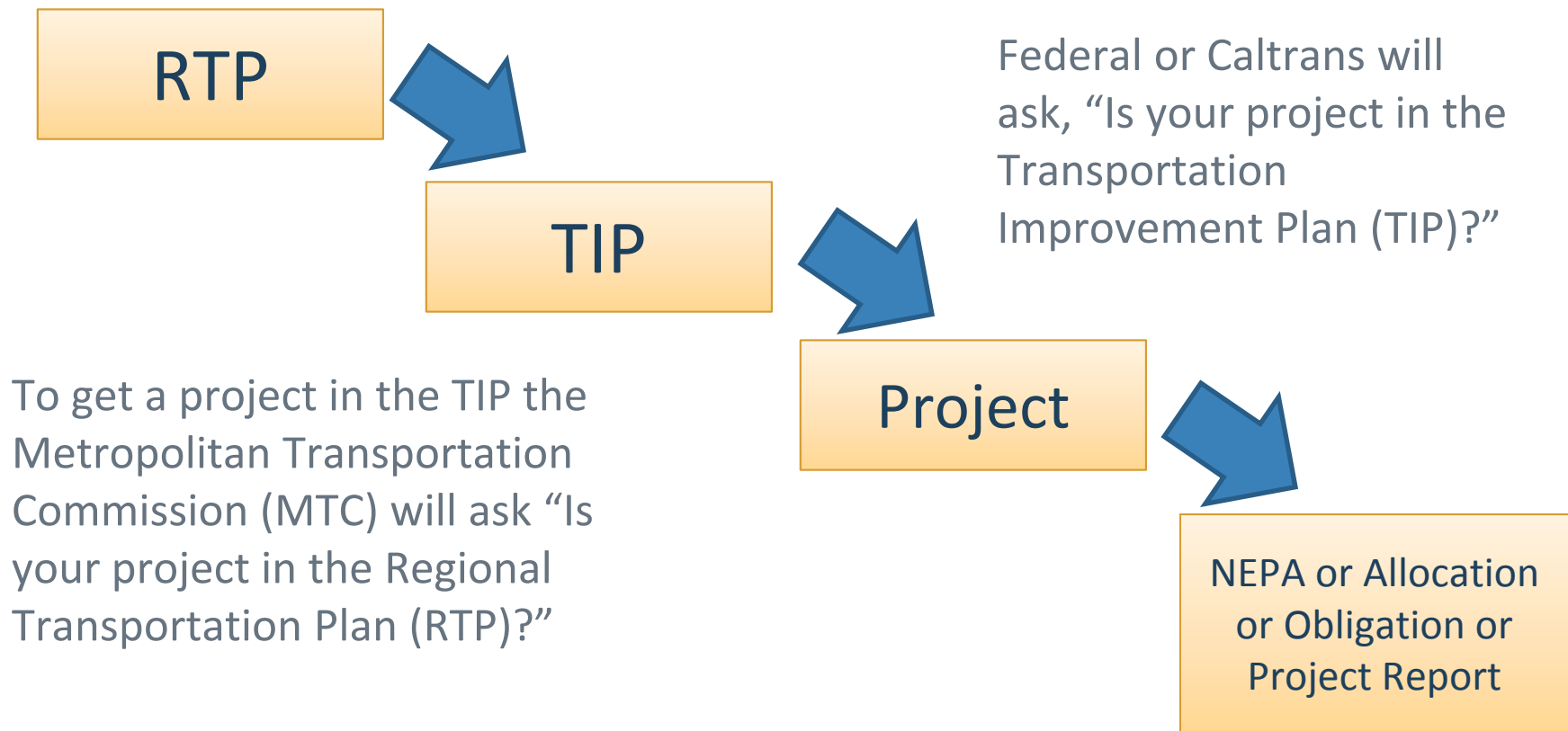
What Does This Mean to a Local Agency?



- ▶ The important part of Plan Bay Area 2050 is to get transportation projects into the plan. Projects that need to be included in the plan meet one or more of the following:
 - Will open for operation after 2021 and by year 2050
 - Will seek federal, state, or regional funding
 - Will require federal or state action
 - Supports the region's sustainable communities strategy (SCS)



How Does the RTP Affect My Project?



Request for Regionally Significant Projects

- ▷ **Regionally-significant projects** is a transportation project that adds capacity to a facility which serves regional transportation needs.
 - Expands the principal arterial roadway system (length greater than ¼ mile)
 - Reduces the number of lanes (length greater than ¼ mile)
 - Adds new or expands access to principal arterial system
 - Adds new or expands transit stations or terminals
 - Total estimated cost is greater than \$250 million
