What is the RTP/SCS?



- ▷ RTP/SCS (Plan Bay Area 2050) is a state mandated, long-range transportation, land-use, and housing planning document
- ▷ Updated every four (4) years
- ▷ MTC is responsible for developing the RTP/SCS
- ▷ **Does not fund any specific transportation projects but sets a high-level roadmap for future transportation investments.**



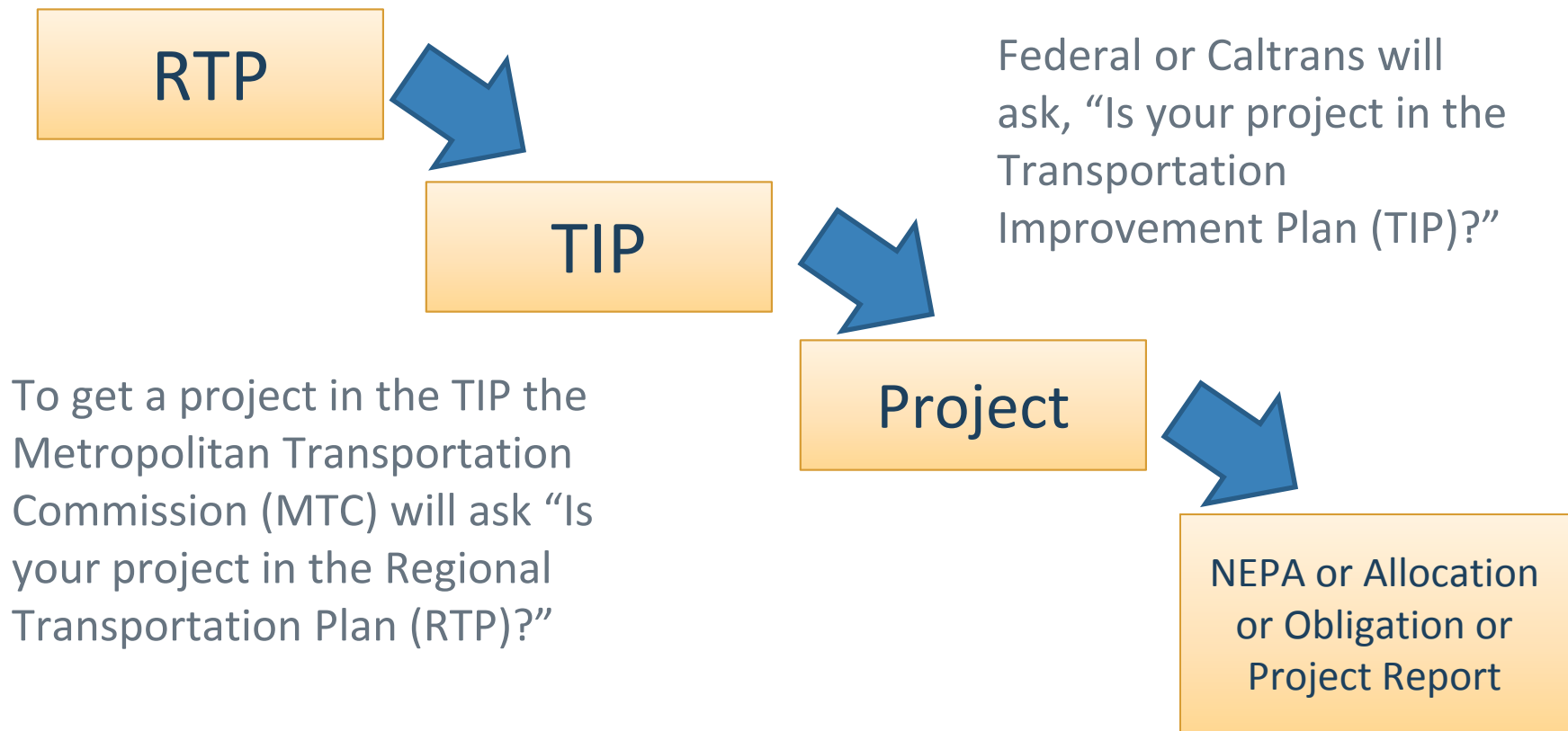
What Does This Mean to a Local Agency?

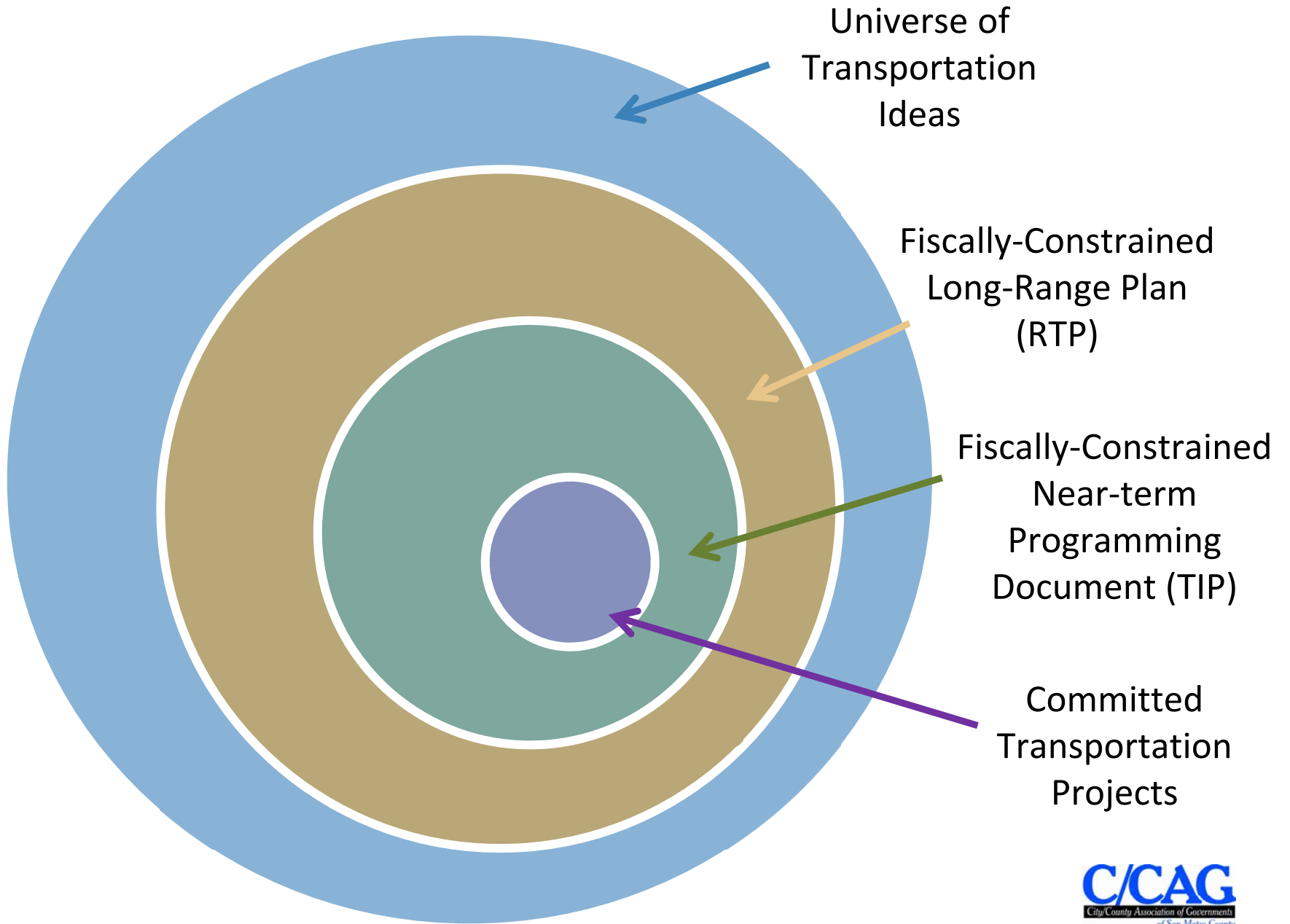


- ▶ The important part of Plan Bay Area 2050 is to get transportation projects into the plan. Projects that need to be included in the plan meet one or more of the following:
 - Will open for operation after 2021 and by year 2050
 - Will seek federal, state, or regional funding
 - Will require federal or state action
 - Supports the region's sustainable communities strategy (SCS)



How Does the RTP Affect My Project?





Request for Regionally Significant Projects

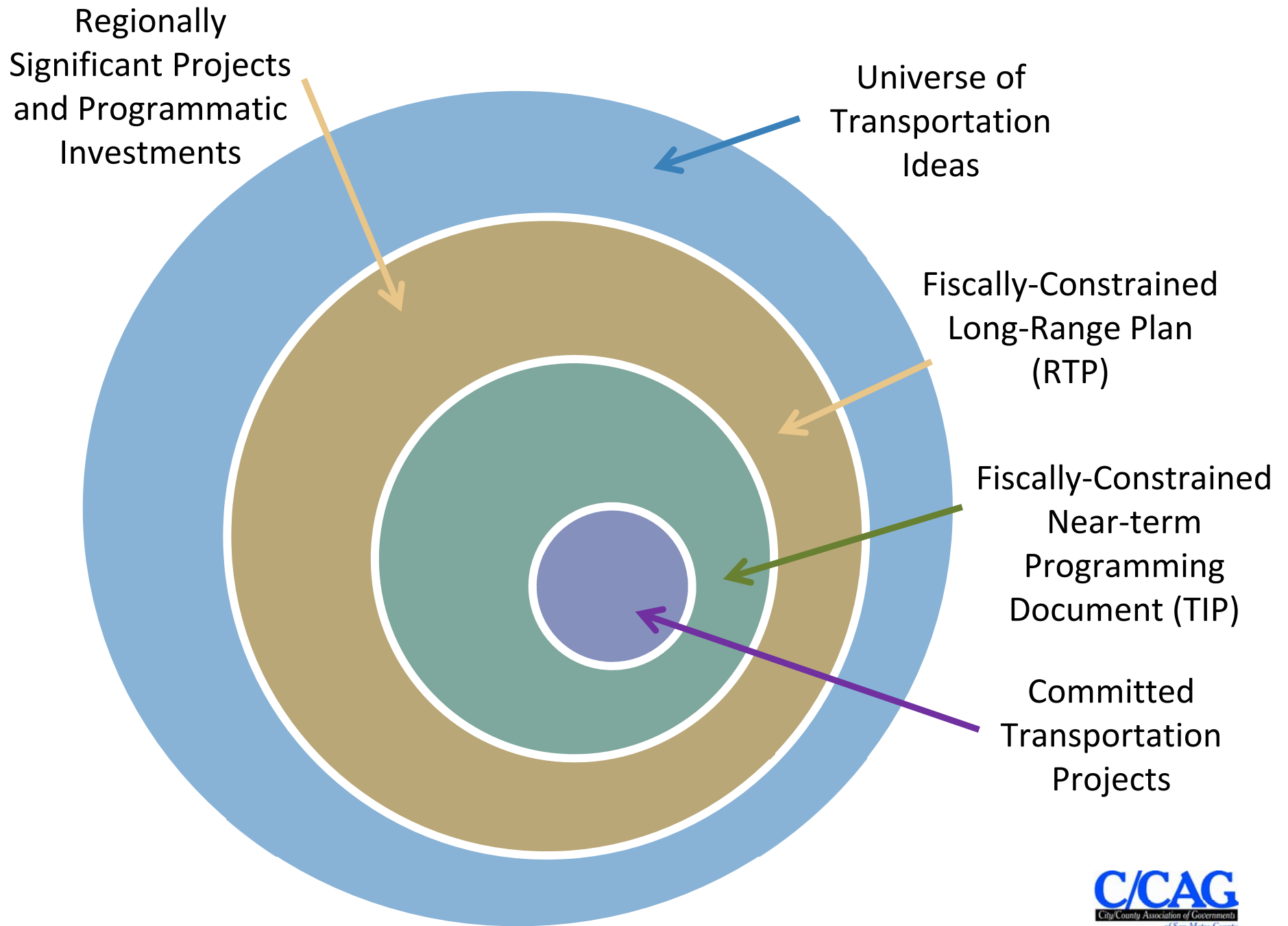
- ▷ **Regionally-significant projects** is a transportation project that adds capacity to a facility which serves regional transportation needs.
 - Expands the principal arterial roadway system (length greater than $\frac{1}{4}$ mile)
 - Reduces the number of lanes (length greater than $\frac{1}{4}$ mile)
 - Adds new or expands access to principal arterial system
 - Adds new or expands transit stations or terminals
 - Total estimated cost is greater than \$250 million
 - **Air-quality conformity analysis is required**



Programmatic Investments

- ▷ Collection of like transportation projects identified by a single listing in the Plan, often grouped by purpose and geography.
- ▷ Exempt from air-quality conformity analysis.
- ▷ Still eligible for both state and federal funding.
- ▷ Still shows consistency with the RTP.
- ▷ Examples: Minor Highway Improvements, Bike/Ped Improvements, Intersection Improvements, and Grade Separation Projects
- ▷ Guidance from MTC anticipated this fall





Draft List of Regionally Significant Projects

- ▷ Request was sent out on March 18th
- ▷ Requests were due on April 10th
- ▷ ~~Strikethrough Projects~~
- ▷ SamTrans Rail Corridor
- ▷ MTC provided financial county target of \$4.6 billion
- ▷ Current total of all regionally significant projects is \$2.6 billion
- ▷ Revised financial target anticipated later this fall
