The two hundred fifty-fourth (254th) meeting of the Technical Advisory Committee (TAC) was held in the SamTrans Offices located at 1250 San Carlos Avenue, 2nd Floor Auditorium, San Carlos, CA. Vice-Chair Porter called the meeting to order on Thursday, August 15, 2019 at 1:22 p.m.

Others attending the meeting were: Al Lee, Nidal Tuqan, Jose Moreno-Jimenez, Becky Frank - Caltrans; Jean Higaki, John Hoang, Kim Wever, Jeff Lacap - C/CAG; Drew – public member; and other attendees not signed in.

1. Public comment on items not on the agenda. None.

4. Receive a presentation on the proposed US 101 Deck Replacement at Alemany Circle (Information)

Al Lee, Nidal Tuqan and Caltrans team presented on the planned US 101 Deck Replacement work and its impacts to traffic on US 101 during the construction phase, planned for July 2020. Comments were as follows:

- There will be backup on Bayshore, therefore, it is suggested that Caltrans staff meets with the Brisbane Council and communicate with the Fire Chief also.
- Will there be extra Caltrans cars? Response was no.
- What is the estimated delay on I-280? Response was that Caltrans do not anticipate much impacts on I-280.
- Suggestion for Caltrans to reach out to the Chambers of Commerce in San Mateo County.
- There are safety issues to be considered.
- Consider advertising message such as "Impacting your 101 Commute."
- Consider advertising through social media

5. Review and recommend formation of a subgroup to provide input to further refine the Draft Data Request Form to track the success of performance measures developed in the San Mateo Countywide Transportation Plan 2040 (Action)

Kim Wever presented the item and requested for volunteers to participate on the subgroup. It was suggested that the staff level group consist of a large, midrange, and smaller cities. An email will be sent out to the TAC with a reminder and requesting for participation. It was also requested that TAC members provide comments on the draft Data Request Form to staff via email.

6. Review and recommend approval of the Draft 2020 State Transportation Improvement Program (STIP) for San Mateo County

Jeff Lacap presented the draft 2020 STIP highlighting three adjustments from the 2018 STIP including 1) moving the 92/101 Interchange design phase out from FY20/21 to FY 21/22, 2) change the implementation agency for the SSF Expansion project from C/CAG to City of South San Francisco, and 3) add funds to the design phase of the US 101 express lane north of I-380.

Jeff Lacap presented on the items, as shown in the staff report including FHWA Policy for Inactive Projects, PMP Certification status, and miscellaneous federal aid related announcements.

BACKGROUND

C/CAG has been coordinating with the cities over the past several years to implement the San Mateo County Smart Corridor (Smart Corridor) project, which provides local cities and Caltrans day to day traffic management capabilities in addressing recurrent traffic congestion as well as provide Caltrans capabilities for managing the system during non-recurring traffic congestion cause by diverted traffic due to major incidents on the freeway. The Smart Corridor includes the deployment of Intelligent Transportation System (ITS) equipment such as an interconnected traffic signal system, close circuit television (CCTV) cameras, trailblazer/arterial dynamic message signs, and vehicle detection system on predefined designated local streets and state routes.

The completed phases of the Smart Corridor Project are along and parallel to El Camino Real (State Route 82) and US-101 and adjacent local streets from I-380 in San Bruno to the southern sections at University Avenue in East Palo Alto. Building on the completed phases, there are two on-going projects that will extend the Smart Corridor in the northern part of the county towards the San Francisco County line:

PROJECT 1: The first project is located in City of South San Francisco along various streets.

PROJECT 2: The second project, referred to as the "Northern Cities Expansion project, is located in the cities of Daly City, Brisbane, and Colma.

PROJECT 1 is in the design phase while PROJECT 2 is in the environmental study phase.

Earlier this year, C/CAG was informed by staff from the Town of Colma, County of San Mateo (County) and Eaton & Associates/Intermountain Infrastructure Group (Contractor), that the County was undertaking a project to install fiber network connectivity between various County sites throughout San Mateo County (COUNTY PROJECT). The COUNTY PROJECT, which crosses into Colma, South San Francisco and Brisbane, will place fiber along many of the same streets that corresponds to where the Smart Corridor project plans to construct its own fiber infrastructure.

Furthermore, Contractor indicated that they were flexible as to fiber placement and was opened to coordinate with C/CAG's Smart Corridor layouts. After reviewing the proposed Smart Corridor routes, Contractor proposed that they could adjust their fiber route to align with the Smart Corridor routes. It was suggested that there was an opportunity for Contractor to place conduits for the Smart Corridor in conjunction with the COUNTY PROJECT for placing fiber for the County. The installation of conduit and fiber by the Contractor would be performed through the respective cities' permit process.

Further discussions between C/CAG and the cities staff concluded that among other factors, two of the major benefits in having Contractor install the conduits for the Smart Corridor project includes alleviating the need for designing for conduit installation and enabling an environmental clearance process with minimal trenching needs, lowering construction cost, and minimizing the need for retrenching the streets.

Contractor provided a cost proposal to perform the work which includes installation of two (2) dedicated 1-1/4" HDPE conduits approximately 31,850 feet in length including dedicated 24"x24"x24" handholes (pull boxes) strategically along the conduit paths per Smart Corridor's requirements. The contractor plans to dig one trench for the Smart Corridor conduits, the County's conduits, and another private party conduit. Therefore, all three sets of conduits will be in the same bank. Included in the cost is that the Contractor will maintain the conduits for a period of 20 years, after which the cities will be responsible to maintain.

The proposed cost, which includes engineering cost, permitting and construction of the Smart Corridor conduits is \$1,250,112.50. Staff have performed independent cost estimates and have determined that it would be cost effective to purchase these conduits through this independent contractor rather than installing conduits as part of the respective projects. The telecommunications grade maintenance and repair times are included at no cost to CCAG for the next 20 years.

Contractor has also reached out the City South San Francisco staff to inform them of Contractor's intent to install similar conduits. It is staff's understanding that Contractor has plans to install similar conduits in City of Brisbane. There are no cost information available for either projects at this time.

SB 1 Local Streets and Roads Funding Program Reporting

To promote statewide consistency in the content and format of project expenditure information submitted to the California Transportation Commission, and to facilitate transparency within the Local Streets and Roads Funding Program, cities and counties are required to report project expenditures for activity during Fiscal Year 2018-19. Project Sponsors are required to log into CalSMART (https://calsmart.dot.ca.gov/login/auth) to report Fiscal Year 2018-19 project expenditures due on October 1, 2019. Highway Program Funding Class

Implementation of New LAPM Form 5-A, Local Agency Invoice

LAPM 5-A will be mandatory for first, progress, and final invoices effective October 1, 2019. Caltrans Local Assistance embarked on a process improvement project to streamline the local agency invoice review process to achieve a statewide consistency with Caltrans' review of local agency invoices, reduce errors and rework, and save time for both local agencies and Caltrans. Caltrans developed a new dynamic invoice form LAPM 5-A that consolidated nine existing forms.

FY 2020-21 Caltrans Sustainable Transportation Grant Application Guide and Call-for-Applications

Caltrans has released the Fiscal Year (FY) 2020-21 Grant Application Guide and call-for-applications for the traditional State and federal funding, as well as grant funding from Senate Bill 1, the Road Repair & Accountability Act of 2017. A total of approximately \$34 million is available for transportation planning projects statewide. The Sustainable Transportation Planning Grants include:

- Sustainable Communities Grants (\$29.5 million) to encourage local and regional planning that furthers state goals, including, but not limited to, the goals and best practices cited in the Regional Transportation Plan Guidelines adopted by the California Transportation Commission.
- Strategic Partnerships Grants (\$4.5 million) to identify and address statewide, interregional, or regional transportation deficiencies on the State highway system in partnership with Caltrans. The transit component that will fund planning projects that address multimodal transportation deficiencies with a focus on transit.

The grant application deadline is October 11, 2019 at 5 PM and grant announcements are anticipated in spring 2020.
