### **Call For Applicants Public Member For The Bicycle and Pedestrian Advisory Committee**

The City/County Association of Governments of San Mateo County (C/CAG) currently has a vacant seat on the Bicycle and Pedestrian Advisory Committee (BPAC). The BPAC provides advice and recommendations to the C/CAG Board of Directors (Board) on all matters relating to bicycle and pedestrian facilities planning and on the selection of projects for certain state and federal funding.

The vacant seat is for a public member. No more than two (2) members, either elected or public, shall reside in the same jurisdiction. The public member must be a resident of one of the Cities listed below.

- Atherton, Belmont, Brisbane, Burlingame, Colma, Daly City, East Palo Alto, Foster City, Half Moon Bay, Hillsborough, Menlo Park, Pacifica, Portola Valley, Redwood City, San Carlos, San Mateo, or Woodside.

The appointment term is for two years. Members may apply for reappointment at the end of his/her term. The C/CAG BPAC meets on the fourth Thursday of the month at 7:00 p.m. at San Mateo City Hall. The C/CAG BPAC reserves the right to review applicants and applications at their discretion prior to board appointment.

Appointments will be considered at the November 14, 2019 Board meeting. If there are still vacancies on the BPAC after the October 25, 2019 deadline, this recruitment may be extended to Friday, November 22, 2019 for appointments to be considered at the December 12, 2019 Board meeting.

Individuals interested in the appointment should submit the attached application and letter of interest **no later than 12:00 PM on Friday, October 25, 2019**. Late applications shall be rejected. Applications and letters of interest must be emailed or mailed to:
