1. Call to order

At 8:33 A.M. Chair Wengert called Finance Committee meeting to order.

2. Public comment on related items not on the agenda.

None

3. Approval of minutes of May 27, 2020 meeting. (Action)

Vice Chair Chuang moved and Member Hurt seconded approval of the minutes. Roll Call was taken. Motioned passed 4-0. (Member Ortiz abstained)

4. Review and provide input to the draft C/CAG Program Budget and Member Fees for Fiscal Year 2020-2021, continued from the May 27, 2020 meeting. (Action)

Chair Wengert suggested to continue the discussion on Member Fees from the May 27, 2020 committee meeting. Sandy Wong, C/CAG Executive Director provided an update that 18 out of 21 jurisdictions responded to the survey of the option to pay the fiscal year 2020/21 Congestion Relief Plan assessment by installments. Of the 18 responses, 10 prefer to pay in full, 8 prefer to pay by installments with the option to defer 50% of the payment to the next one or two fiscal year(s). Either preferences were well spread out in terms of size of jurisdiction. Chair Wengert asked how that would impact the Congestion Relief Plan budget. Sandy Wong, C/CAG Executive Director explained that with 50% of the assessment paid in fiscal year 2020/21 and the

remaining 50% to be paid later, the FY 2020/21 programs and projects will be delivered. The Finance committee members discussed various member fee payment options and the need to address equity and any impact on critical projects funded by the Congestion Relief Plan fee. A concern was also raised regarding the mechanism to guarantee the remaining 50% installment will be paid, and the option of deducting from that member's Measure M distribution in the event of default.

Member Benton moved to recommend that due to the impact of COVID-19 this year, the Congestion Relief Plan Member Fee for FY20-21 should be reduced by 50% and not have members payback in future years and Member Ortiz seconded. Roll Call was taken. Motioned passed 5-0.

The Finance committee members reviewed the C/CAG Program Budget. Chair Wengert commented that the reserves have substantially decreased which is what the committee has been requesting. Member Benton noticed the new fund for the Express Lanes JPA. Sandy Wong, C/CAG Executive Director explained the new fund was set up to track operating loans to support the startup of the Express Lanes JPA, to be paid back with future express lane toll revenues. Both C/AG and the TA have committed to provide support to the Express Lanes JPA.

Member Ortiz moved to recommend the proposed C/CAG Program Budget as is and Member Hurt seconded. Roll Call was taken. Motioned passed 5-0.

RECOMMENDATION

That the C/CAG Finance Committee receive updated information on Congestion Relief Plan and Congestion Management Program and provide input to the draft C/CAG Program Budget and Member Fees for Fiscal Year 2020-21.

FISCAL IMPACT

In accordance with the proposed C/CAG 2020/21 Program Budget.

SOURCE OF FUNDS

Funding sources for C/CAG include member assessments, cost reimbursement from partners, grants, regional - State - Federal transportation and other funds, property tax/fee, Department of Motor Vehicle fees, State - Federal earmarks, and interest.

BACKGROUND

Each year, the C/CAG Board reviews the draft annual budget and member fees in the month of May and approves the final budget in June. Staff presented the draft C/CAG budget and member fees for fiscal year 2020-21 to the C/CAG Board on May 14, 2020.

At the May 27, 2020 Finance Committee meeting, the Committee received a presentation on the draft C/CAG budget and member fees for fiscal year 2020-21. Due to time limitations, the Committee tabled the draft budget discussion to the next meeting on June 1, 2020. At the June 1st Finance Committee special meeting, the Committee made a recommendation to adopt the C/CAG budget and member fees for fiscal year 2020-21, waiving 50% of the Congestion Relief Plan Fund fee for fiscal year 2020-21.

The Finance Committee's recommendation at the June 1, 2020 meeting was primarily based on the understanding that the fee waiver would not have any negative impact to the C/CAG Congestion Relief Program, and yet would provide positive financial relief to member agencies in light of COVID-19. Since C/CAG is on a single-year budgeting cycle, and since there is sufficient fund balance in the Congestion Relief Fund, staff informed the Finance Committee that there are sufficient funds to support the planned congestion relief programs/projects for fiscal year 2020-21.

Staff has surveyed the local jurisdictions on their preference of paying the FY 2020/21 Congestion Relief Plan annual assessment in full, or by installment with the flexibility of deferring payment of 50% of the assessment to the next one or two fiscal years. 10 jurisdictions responded with the preference of paying in full, 8 jurisdictions responded with the preference of paying by installment. 3 jurisdictions did not respond.

Additional Information

After the Finance Committee meeting, staff began to prepare the Final Fiscal Year 2020-21 Budget incorporating the Finance Committee's recommendation. As staff researched the detail of the Congestion Relief Plan as adopted by the C/CAG Board in 2019, staff realized that there were three additional pieces of information that would be relevant to the Committee's recommendation.

First, the Congestion Relief Plan (CRP) is a four-year program of activities, member assessment, and budget. It was developed in consultation with, and reviewed and recommended through the Technical Advisory Committee (TAC) and Congestion Management & Environmental Quality (CMEQ) Committee, and approved with special voting procedures by the C/CAG Board in May 2019. Any material changes to the Congestion Relief Plan, including its member assessment, would require amendment of resolution 19-32, which adopted the CRP and authorized the assessment. For further information on C/CAG Resolution 19-32 and its associated detailed documentation, please see Attachment 2.

Second, pursuant to state legislation and California Government Code Section 65089, C/CAG as the Congestion Management Agency for San Mateo County, is required to prepare and adopt a Congestion Management Plan (CMP) for San Mateo County on a biennial basis. The CMP legislation requires certain specific elements be included in the Congestion Management Program. One of the required elements is a local jurisdiction prepared Deficiency Plan when roadway level of service standards are not maintained on segments or intersections of the system within that jurisdiction. The countywide Congestion Relief Plan (CRP), including the annual assessments, has been incorporated into the CMP. Please see Attachment 3 – Chapter 7 of the adopted 2019 CMP. The CRP was developed to serve as a Countywide Deficiency Plan such that the individual cities and the County would not have to develop multiple deficiency plans with corresponding implementation costs. The C/CAG Board adopted the 2019 CMP on April 9, 2020, in compliance with all the required process including conducting a public hearing. Further, in accordance with C/CAG Bylaws, the adoption of the CMP requires a minimum of 25-day review period. Hence, any amendment of the CMP will need to follow the same process.

Third, staff has proposed a budget which assumes 50% of the FY 2020/21 Congestion Relief Plan Assessment will be collected in FY 2020/21, and the remaining 50% will be collected in the following one or two fiscal year(s). Such proposed installment option would not affect the adopted annual assessment. Please see Attachment 1.

While the proposed installment option would not have impact on program services in fiscal year 2020/21, it is unknown if there would be a potential negative impact on programs or service delivery in later years (Fiscal Years 2021-22 and 2022-23), if the Board waives 50% of the assessment for FY 2020/21. Future year programs and projects would depend on multiple variables, including workflow, costs of the programs and projects, and the potential availability of other sources of funds and grants.
