#### 1. Brief Overview of Teleconference Meeting Procedures

Committee staff provided a brief overview of teleconference meeting procedures.

#### 2. Roll Call and Introductions

Committee staff completed Roll Call and a quorum of seven Committee members was eventually achieved allowing action on the minutes and meeting date items.

#### 3. Public Comments on items not on the agenda

There were no public comments received by email or delivered by meeting participants.

4. Approval of minutes of November 17, 2021 RMCP Committee meeting.

The minutes of the November 17, 2021 meeting was approved; Motion by Kohl-Zaugg and Second by Smith: (7,0,0)

**5.** Review and approval of RMCP Committee meeting dates through January 2023. The meeting dates for February 2022 through January 2023 were approved; Motion by Lopez and Second by Francis: (7,0,0)

# 6. Bay Area Water Supply and Conservation Agency update on water supply and drought conditions in San Mateo County, the Regional Water Supply Reliability Roundtable, and the SFPUC Long-term Vulnerability Assessment.

Tom Francis provided an update on the current statewide water supply and drought conditions, including rainfall and water use trends in San Mateo County.

Though we've had rain and there has been improvement in the drought maps, most of the state is still in severe drought. Most reservoirs in the state are at 50% to 70% of past annual average capacity, so more rain is needed. To help with the drought, the state needs a lot of both rain and snowpack in February, March, and perhaps April. The snowpack, at this point, is doing well, but little rain or snowfall is predicted for rest of January into February.

Since the January meeting, the SFPUC has declared a water shortage emergency with a voluntary, systemwide 10% cutback. Water agencies are tracking water use over the next twelve months. The SFPUC is tracking results and deciding when and if mandatory rationing will become necessary.

BAWSCA is in the process of hiring a consultant to support the Water Supply Roundtable through a Statement of Qualifications (SOQ). Selection was supported by BAWSCA and C/CAG and a water agency. It is anticipated that the Roundtable will meet two time before the end of June 2022.

The SFPUC has posted the Long-Term Vulnerability Assessment, which is a 240-page report, the link to which is provided in the BAWSCA presentation posted on the C/CAG RMPC website for this January 2022 meeting.

#### 7. Update on La Honda Community Microgrid project.

John Ellis provided an update on the potential La Honda microgrid project, which, at this time, includes a short-, mid-, and long-term plan. A focus of the project currently is finding a solution for the La Honda Schools, which serves 50-60 families in La Honda and depends on electricity for pumping of water. For teachers, who all live in La Honda, purchase of 4-6 kWH power back up boxes for exchange at the school is being considered. Lighting efficiency for teachers' homes is also being considered. The Cuesta community guild is being considered for islanding as a relief

center for the community, on high heat days for instance. Current partners are PG&E, C/CAG, Peninsula Clean Energy, and South Coast Sustainable.

# 8. Presentation on new single- and multi-family homeowner and contract electrification incentive program.

Peter Florin from Energy Solutions and Alison Seel from Vermont Energy Investment Corporation, partners on the TECH Clean California Program. The Program is California's first big effort to transform the heat pump market. The effort aligns with the states goal of carbon-free homes by 2045. The Program serves single family and multifamily residences in the IOU gas territories, including those customers using propane gas. Funding comes from Cap-and-Trade funds proportional to gas-IOU allowances at approximately \$120 million over the next few years.

The Program provides both training and incentives, with the goal of collecting data to help analyze both he success of the program and how future programs can be improved in the future. Training if provided to contractors and incentives are also provided to contractors, which they must pass on to the customer. That may become flexible to the contractor in the future. Incentives can be stacked with BayREN or PCE incentives for transition to heat pump water or space heating systems. As a result, incentives are significant. For instance: gas or propane to Heat Pump Water Heating can be as much as \$3,100.

Committee members expressed interest and concern for multi-family electrification and presenters reviewed both he multifamily incentives in the TECH California program, which provides for electrical panel upgrades, and a new TECH Multifamily pilot program, which could be invited to present to the RMCP Committee at a future meeting.

#### FISCAL IMPACT

None. Funding for this Laundry to Landscape program have not yet been identified.

#### **BACKGROUND/DISCUSSION**

Concerns about drought in California and potential consequences, such as the need for considerable rationing of water use, in San Mateo County spurred greater discussion by the RMCP Committee in calendar year 2021. Topics such as One Water and water capture and reuse programs, including residential Laundry to Landscape were discussed by the Committee.

At the April 21, 2021 RMCP Committee meeting, staff provided a presentation on One Water. At the July 21, 2021 meeting, County Environmental Health provided a presentation on nonpotable guidelines for water reuse and BAWSCA presented a draft of their Water Supply Reliability Roundtable concept. At the August 18, 2021 Committee meeting, staff invited Laura Allen from Greywater Action to present on residential grey water systems, which was mainly focused on Laundry to Landscape. At the October 20, 2021 Committee meeting, staff invited Carol Steinfeld to present on the Loma Prieta Chapter of the Sierra Club's effort to develop a model water conservation ordinance.

In coordination with BAWSCA and other stakeholders such at County OOS, staff has developed a proposed scope for a countywide residential Laundry to Landscape program for San Mateo County. The draft proposal is provided as an attachment to this staff report.

The draft has been presented for review and comment to BAWSCA and County OOS staff, as well as Santa Clara Valley Water staff, who have been implementing a broad residential water reuse program for about eight years. The current draft considers feedback from these agencies and is presented to the RCMP Committee for review and comment.

The proposed program scope is not funded at this time. Once positive feedback and comments from the Committee and others has been received and incorporated, staff will review the

proposed scope with state and federal funding advocates and grant providers to source funding for the program. Because there are opportunities to expand the program, staff may seek funding up to \$300,000.

#### Residential Laundry to Landscape Program Proposal Gray Water Capture as Conservation

The risk of drought is real. San Mateo County's Pacific coastal and Bayside (especially at-risk-) communities may have to address new and potentially severe water conservation mandates in multiple-year scenarios of California drought.

Water conservation (reducing demand on potable supply) has traditionally been low-flowfixture focused. However, reframing the future of adapting to ongoing drought to reducing potable water supply use, a more one-water capture approach, is key. To this end, C/CAG proposes, working with multiple community partners, to educate the public about residential gray water capture-to-landscape opportunities, already allowed, without residential permitting requirements based on the current CA plumbing code. There is a need to develop consistent understanding across city building departments, contractors (landscape and plumbing), and residents about what is allowable, considerations of use, how to install a "system", and the potential for water supply savings.

This project will help build consensus and awareness of the potential impacts of drought, the allowable "laundry-to-landscape", without permit, onsite water capture and reuse opportunities, so that residents and homeowners are resourced and empowered to act. This project will also help eliminate any existing confusion and, therefore, staff time for city building and planning departments, related to permit-less onsite residential water capture opportunities.

- Build website content focused on one water, and water capture and reuse (for existing websites, C/CAG, city, BAWSCA, RCD, CBOs)

  - Grantor credited with funding the project
- Task 2: Stakeholder Training
  - Provide training for <u>Three Audiences</u>
    - <u>Water agencies, building departments, and sustainability staff</u> Plumbing Code education: when permitting IS required, and when not
    - <u>Contractors, landscapers, and handypersons (focus on small, disadvantaged</u> <u>businesses</u>) – what is required for a GW2L installation and best practices
    - <u>Residents and homeowners</u> know the GW2L installation requirements and best practices for soil and human health

#### FISCAL IMPACT

None. Funds from the San Mateo County Energy Watch, PG&E local government partnership program cover the costs of the program.

#### **BACKGROUND/DISCUSSION**

The San Mateo County Energy Watch local government partnership program between C/CAG and PG&E launched over thirteen years ago in 2009. The program focuses on energy efficiency, and may also promote electrification, EV charging, and energy resilience at customer sites. C/CAG with PG&E, and the County Office of Sustainability (OOS) with C/CAG, are in contract for OOS to manage and staff the Program through June 2023. As of the end of December 2021, the SMC Energy Watch (SMCEW) program has completed 18-months of its 36-month program cycle. This program cycle, the SMCEW team has coordinated with both internal and external partners to provide technical and financial assistance in the small business, public school, and municipal sectors.

In late 2021, PG&E, a third-party contractor to PG&E (Willdan), and OOS coordinated to launch a Heat Pump Water Heater (HPWH) pilot that installed HPWHs a several municipal sites in San Mateo County. The program will continue into 2022 as PG&E and CPUC goals provide more opportunity for GHG emission reducing, fuel switching programs at customer sites. This new pilot was presented by OOS at the November 17, 2021 RMCP Committee meeting.

Susan Wright, Resource Conservation Programs Manager at the County Office of Sustainability, will return to present an update to the Committee on both the municipal HPWH pilot as it moves into calendar year 2022, and the other offerings to municipalities through the San Mateo County Energy Watch program.

#### FISCAL IMPACT

#### **BACKGROUND/DISCUSSION**

To achieve carbon neutrality by 2045, the State of California has funded a new program called Tech Clean California. The program is a \$120M initiative focused on single- and multi-family homes. 40% of the program benefits are targeted towards low-income and disadvantaged communities.

At the January 19, 2022 RMCP Committee meeting, Peter Florin from Energy Solutions presented on the TECH Initiative single family and multifamily incentives program. Committee members provided feedback to the presenters and expressed interest in a presentation on the multifamily pilot program, which held a stakeholder meeting near the end of last month on January 26, 2022.

TECH Clean California multifamily program will provide incentives, pilot efforts, technical assistance, and training to help overcome barriers to electrification and energy efficiency upgrades in multifamily properties. The Program coordinates with BayREN and shares the consultant invited this month to present, so the two programs are in collaboration.

The TECH Multifamily initiative and pilot program is led by consultant Association for Energy Affordability (AEA). Nick Dirr, Senior Director of Program for AEA, will present the program and pilot elements to the Committee, and Chris Hunter, Program Services Specialist with Alameda County StopWaste will co-present on elements of the BayREN Multifamily program.
