RE: SB 922 (Wiener) California Environmental Quality Act: Exemption: Transportation-Related Projects. – SUPPORT IF AMENDED

Dear Chair Rivas:

On behalf of the City/County Association of Governments of San Mateo County (C/CAG), I write to voice our SUPPORT IF AMENDED for SB 922 (Wiener). This bill would modify the statutory exemptions to the California Environmental Quality Act (CEQA) for clean transportation projects, established by SB 288 (Wiener) [Chapter 200, Statutes of 2020] and extend the sunset date to January 1, 2030. We respectfully request that you consider an amendment that would address all housing displacement, not just "affordable" housing displacement as currently written.

In 2020, Governor Newsom signed into law SB 288, temporarily exempting from CEQA certain clean transportation projects, including projects for roadway improvements aimed at improving bicycle & pedestrian access; new bus rapid transit service, bus, or light rail services on public rail or highway rights-of-way; projects that improve customer information and wayfinding for transit riders, bicyclists, or pedestrians; and projects to construct or maintain infrastructure to charge or refuel zero-emission buses.

SB 922 (Wiener) modifies the CEQA exemptions provided by SB 288 to include additional project types that will further expedite the delivery of clean transportation options and expand access to alternative modes of mobility. SB 922 (Wiener) extends the sunset on these exemptions for seven years. C/CAG, as the Congestion Management Agency (CMA) for San Mateo County, often has a lead role in implementing active transportation and traffic management programs and projects. SB 922 further solidifies the role of CMAs as a lead agency under the bill and will help C/CAG bring environmentally friendly projects online sooner, while reducing project costs. For these reasons, we SUPPORT SB 922 (Wiener) and ask that you please consider our suggested amendment.
