C.17 Discharges Associated with Unsheltered Homeless Populations

- **Goal - Implement control measures to address non-stormwater discharges into MS4s from unsheltered homeless populations that impact water quality**
- **New Provision**
 - Many activities conducted outside of SW Program
- **Submittals**
 - September 2023 Annual Report
 - September 2025 Annual Report
- **Submittals will inform MRP 4.0 requirements**

September 30, 2023 Annual Report Submittals

- **Regional BMP report**
 - Practices and programmatic efforts being implemented at local/ Countywide/regional level
- **Permittees report BMPs implemented & effectiveness evaluation**
 - BMP implemented
 - Approx. portion of homeless population/locations being served
 - Approx. portion of population/locations not being reached/not fully reached
 - Additional actions/changes to improve existing practices
- **Permittees submit a map**
 - Locations of unsheltered homeless populations
 - Locations in relation to storm drain inlets and/or surface water bodies

Regional BMP Report

- **BAMSC Project Profile**
 - SMCWPPP providing in-kind services through EOA staff participation
- **BAMSC Work Group**
 - Develop outline for countywide reports
 - Develop Executive summary for Regional Report
- **Beginning December 2022, EOA will be requesting reports/documents/information on practices and activities**

Permittee Submittals

■ **Permittee Map**

- EOA will create maps using available data from County Point-In-Time Count and storm drain systems
- Permittees provide local data, as available

■ **Permittee Annual Report**

- EOA will provide guidance
- Permittee information collected for Regional Report also used for Annual Report

■ **SMCWPPP Work Group**

- Review BAMSC draft outline and draft executive summary
- Review SMCWPPP Annual Report guidance materials

Stormwater Committee

- **Identify point-of-contact**
 - Collect information from staff/programs outside of Stormwater Program
 - Does not require participation in Work Group
