BACKGROUND

The Bay Area Housing Finance Authority (BAHFA) is part of the MTC and is focused on increasing funding for affordable housing throughout the region. BAHFA is the first regional housing finance authority in the state and is planning to place a \$10-\$20 billion affordable housing bond measure on the November 2024 ballot to benefit the nine-county Bay Area. This money would be used to build affordable homes and help keep existing housing affordable in every county. 80% of the funds will return to the County in which it is generated for affordable housing development and preservation. The remaining 20% will be allocated through a regional program to support local housing efforts.

BAHFA provided a presentation on the proposed 2024 regional affordable housing ballot measure to the C/CAG Board of Directors on June 5, 2023. At the February 8, 2024 C/CAG Board of Directors meeting, BAHFA will provide an updated presentation on the proposed 2024 regional affordable housing ballot measure. Staff, Kim Springer, Transportation Systems Coordinator, and consultant, Chris Lepe, Mariposa Planning Solutions, provided a brief presentation on the C/CAG Equity Assessment and Framework Development Project Final Report and Action Plan, with a recommendation to adopt the final report.

C/CAG Executive Director, Sean Charpentier described a vote that was taken at the Legislative Committee; potential inclusion of transit consolidation including BART and Caltrain in a regional measure effort by MTC. It was noted that the C/CAG Legislative Committee recommended sending a letter expressing concerns about consolidating Caltrain and BART. Staff requested Board authorization to send a letter to MTC expressing concerns about any potential consolidation of Caltrain and BART.

Board Member Lewis MOVED to approve item 4.4. Board Member Nicolas SECONDED. A roll call vote was taken. **MOTION CARRIED 16-0-1 (San Mateo abstains.)**

In addition, a retreat is being planned in the next couple of months.

5.2 Board Members Report/Communication

Board Member/MTC Commissioner reported that MTC is coordinating a housing bond coming forward next year. In trying to make sure all of our cities are involved in the process, Commissioner Papan and Sean Charpentier are trying to coordinate with all of the city managers in which they can all have a say in how this moves forward. The funding will come through the county. Secondarily, MTC is working on a transportation bond the following year. Commissioner Papan is hoping to get all of our jurisdictions in particularly locally our transit operators are an active part of that process, so that it benefits San Mateo County to the fullest extent, and that each and every city has input moving forward, this will be approved by the voters.

Sean Charpentier reported that we are planning to have the BAHFA, which is the MTC department related to the affordable housing measure present to the C/CAG Board at the February meeting, and they are planning to present to the city manager's monthly meeting early next calendar year. We are potentially having several community pop-up events related to our local streets and roads safety plan next week. In addition, the January Board meeting may be cancelled due to a light agenda. Sean has thanked the staff for all their accomplishments in the last year and has thanked the Board for all of its support.

BACKGROUND

There are 21 local government jurisdictions in San Mateo County (20 cities/towns and 1 County). C/CAG focuses on Countywide collaboration and creating alignment on solutions for the entire county. The C/CAG Board of Directors is one of the few organizations in the County that has a specified seat for each city/town and the County. In addition, C/CAG has an extensive system of committees, with a total of 8 standing committees to guide and advise the C/CAG Board of Directors. C/CAG has approximately 76 regular scheduled Brown Act meetings each year for C/CAG Board of Directors and C/CAG Committees. Including the Board of Directors and the 8 standing committees, there are a total of 139 seats, including 74 seats identified for elected officials. There are 107 elected councilmembers or County Supervisors in San Mateo County. In 2022, approximately 52 individual (unduplicated) local elected officials either served on the C/CAG Board of Directors or participated with a C/CAG Committee.

Periodically, the C/CAG Board receives reports of the attendance for the Board and its standing committees. Since each member jurisdiction appoints its C/CAG representative and alternate, C/CAG has not set an attendance requirement for Board meetings. However, the C/CAG Board adopted the following attendance policy for its standing committees:

"During any consecutive twelve-month period, members will be expected to attend at least 75% of the scheduled meetings and not have more than three consecutive absences. If the number of absences exceed these limits, the seat may be declared vacant by the C/CAG Chair."

The attached attendance reports are provided for your acceptance.

RECOMMENDATION

That the C/CAG Board review and approve Resolution 24-1 authorizing the C/CAG Executive Director to execute an agreement between C/CAG and the County of San Mateo Office of Sustainability for staff services to support the Regionally Integrated Climate Action Planning Suite (RICAPS) program in an amount not to exceed \$50,000 for calendar year 2024 and 2025.

FISCAL IMPACT

Up to \$50,000.

SOURCE OF FUNDS

Congestion Relief funds in the amount of \$50,000 as included in the FY 2023/24 budget. Funding for calendar year 2025 is subject to C/CAG budget approval.

BACKGROUND

On September 16, 2010, the C/CAG Board adopted Resolution 10-53 authorizing the C/CAG Chair to execute an agreement with the BAAQMD to receive a \$50,000 grant, launching the C/CAG Climate Action Plan Template and Tool project. On March 7, 2011, the C/CAG Board adopted Resolution No. 11-11 for a PG&E Contract Work Authorization No. 2500458103 between C/CAG and PG&E for \$125,000. The total grant funding for Climate Action Plan Template was \$175,000, and with C/CAG's commitment to match funds, the total project budget was \$350,000 through calendar year 2012. The project eventually came to be known as the Regionally Integrated Climate Action Planning Suite (RICAPS).

C/CAG began contracting with the County of San Mateo to provide staff services for RICAPS for \$60,000 in 2012, \$50,000 in 2013, and subsequently every year through 2018 in an annual amount of \$40,000. For 2019 and 2020, that amount was increased to \$50,000 due to a 55% reduction in funding

from PG&E for these types of services to cities. Because approximately \$18,000 remained unspent at the end of calendar year 2020, the Executive Director extended that agreement through FY 2020/21. The extension aligned the cycle of the new agreement with the fiscal year. For fiscal year 2021/22, the County Office of Sustainability requested funding for staff services to continue this program at a reduced amount of \$25,000. The reduction was due to C/CAG hiring staff from the County Office of Sustainability, who will partially support the program as C/CAG staff. For fiscal year 2022/23, C/CAG continued to fund the County Office of Sustainability at an amount of \$25,000.

C/CAG funding for staff services comes from Congestion Relief Funds, serving as a match to the PG&E Local Government Partnership grant. Since climate action planning support covers all sectors of GHG emissions: energy, transportation, solid waste and other emissions, the funding will support RICAPS efforts not necessarily related to energy. For this reason, staff wishes to continue to fund the County Office of Sustainability \$25,000 per year. Resolution 24-1 and the draft Staff Services Agreement for RICAPS are provided as attachments to this staff report.

The goal of RICAPS is for every city in San Mateo County and the County to have adopted plans to reduce greenhouse gas emissions, a means to track individual jurisdiction and countywide progress though greenhouse gas emission inventories, and to provide ongoing implementation and technical support.

Tracking greenhouse gas emissions for each city in the county (including transportation emissions), and providing resources to cities to reduce emissions, will positively impact vulnerable communities by improving both indoor and outdoor air quality. Though the San Mateo County Energy Watch (SMCEW) program is not funded to address the needs of the residential sector specifically, the RICAPS climate program works closely with city staff and Peninsula Clean Energy to spread awareness of electrification opportunities, including to the residential sector.

The SMCEW serves the small, disadvantaged business sector, defined by the CPUC as English as a second language, fewer than 10 employees, low energy use, and renting or leasing brick and mortar space. The program for this sector is provides information on energy-saving opportunities and incentives and is dovetailed with the County's green business program, which addresses solid waste-and water-saving opportunities. SMCEW staff work in the field, directly with these small businesses and provides program funds to community-based organizations to support outreach. In the last program cycle, which occurred mostly through the COVID pandemic, a very difficult time for small businesses, the program outreached to approximately 3,500 businesses passively, with approximately 350 inperson visits, resulting in ten project referrals. From July 1, 2023 to date, the program has referred 16 additional projects.

FISCAL IMPACT

The budget would increase by \$38,172 from \$338,150 to a new not to exceed amount of \$376,322.

SOURCE OF FUNDS

Funding for the project will come from federal Surface Transportation funds and local Congestion Relief Plan funds. The Congestion Relief Plan funds will be used for the 11.47% local match requirement.

BACKGROUND

A Local Roadway Safety Plans (LRSP) identifies and analyzes roadway safety needs and develops a prioritized list of safety countermeasures. The LRSP also contributes to the California Strategic Highway Safety Plan (SHSP), which aims to reduce traffic fatalities and serious injuries across the State's roadways. The process of preparing an LRSP creates a framework to systematically identify and analyze safety problems and recommend safety improvements. Preparing an LRSP facilitates the development of local agency partnerships and collaboration, resulting in a prioritized list of improvements and actions that can demonstrate a defined need. The LRSP offers a proactive approach to addressing safety needs and demonstrates agency responsiveness to safety challenges.

The San Mateo Countywide LRSP will identify existing conditions of the county's roadway network and provide a framework for systematic safety improvements in the areas of engineering, enforcement, education, and emergency response. In addition, the completion of the countywide LRSP will render jurisdictions in the County eligible for grant funding from the Metropolitan Transportation Commission (MTC) OBAG 3 County & Local Program, and future funding for Caltrans Highway Safety Improvement Program and US Department of Transportation Safe Streets for All (SS4A).

In March 2023, the C/CAG Board approved Resolution 23-22 authorizing a contract with Kittelson & Associates for the preparation of the San Mateo Countywide Local Roadway Safety Plan in an amount not to exceed \$338,150. Upon execution of the contract, staff determined incorrect dates were listed in the Agreement and that a recital included the incorrect non-to-exceed amount. Accordingly, Contract Amendment No. 1 was executed correctly reflect the term of the Agreement from March 15, 2023 to March 31, 2024 and to identify the correct not-to-exceed amount of \$338,150.

Proposed Amendment No. 2

As part of the project scoping work in spring 2023, C/CAG staff reviewed LRSP information from MTC and Caltrans and reached out to local agency staff and determined that 10 of the 21 jurisdictions in San Mateo County County did not have a safety plan adopted or currently working on their own safety plan; the Town of Atherton was assumed to have a completed/in-progress plan. The other jurisdictions with a completed/in-progress safety plan include:

- Burlingame
- Daly City
- Millbrae
- Menlo Park (In-progress)
- Pacifica
- Redwood City
- San Bruno
- San Mateo (City) (In-progress)
- San Mateo County
- South San Francisco

Each of the remaining jurisdictions would have a dedicated chapter in the countywide LRSP determining priority locations and countermeasure recommendations. C/CAG would also reference the other jurisdictions' safety plans in the Countywide LRSP.

As work on the San Mateo Countywide LRSP was underway in the fall 2023, the Town of Atherton informed C/CAG staff that they would not be able to use the LRSP funding that was provided by Caltrans on their own and would be relying on the Countywide LRSP as their safety plan. However, the budget was only scoped for only 10 jurisdictions and did not include the Town of Atherton. Staff explored multiple pathways to incorporate the funding that the Town of Atherton received from Caltrans to supplement the budget for the Countywide LRSP, but ultimately recommends utilizing \$15,000 under Amendment No. 2 to develop a chapter in the LRSP for the Town of Atherton to avoid possible delay due to added administrative tasks.

Additionally, C/CAG staff is exploring submitting an application for the next round of the US Department of Transportation Safe Streets for All (SS4A) grant program, slated to open this month. A

budget augmentation of \$23,172 of the project contingency is proposed to be added to Task 10: SS4A Application Support, to assist in the preparation of a grant application.

To ensure there is sufficient time to complete the local review process, a four-month time extension to July 31, 2024, is also proposed.

EQUITY IMPACTS AND CONSIDERATIONS

The San Mateo Countywide LRSP is a countywide plan that will ultimately include each of the jurisdictions in the county. As part of the development of the safety plans for the 11 jurisdictions that is being developed by C/CAG, locations within a MTC Equity Priority Community and the C/CAG Equity Focus Areas was use as a metric in the prioritization process.

RECOMMENDATION

That the C/CAG Board review and approve Resolution 24-4 amending the funding allocation for the US-101 Managed Lanes Project - North of I-380 in the 2024 State Transportation Improvement Program (STIP) for San Mateo County.

FISCAL IMPACT

There is no direct fiscal impact to C/CAG other than staff time. Upon CTC approval, the STIP funds will be allocated to project sponsors directly.

SOURCE OF FUNDS

Funding for the 2024 STIP Program will come from both state and federal funding sources.

BACKGROUND

<u>2024 STIP</u>

The State Transportation Improvement Program (STIP) is the biennial five-year plan for future allocations of state transportation funds. It is a five-year document adopted every two years by the California Transportation Commission (CTC) to program certain portions of the gas tax for transportation projects. The Program is developed in coordination with the Metropolitan Transportation Commission (MTC).

San Mateo County is projected to receive approximately \$37 million from the 2024 STIP. C/CAG staff will use this as a working estimate, which may later be adjusted by CTC upon adoption of the final STIP Fund Estimate. The 2024 STIP identifies net new capacity only in the outer two years of the 2024 STIP, FY 2027-28 and FY 2028-29. Therefore, 2024 STIP funds can only be programmed within those two fiscal years.

For San Mateo County, C/CAG is the designated agency responsible for developing the regional share of the STIP. STIP candidate projects must be consistent with the Regional Transportation Plan as well as the County's Congestion Management Program.

The 2024 STIP, including its proposed technical changes and new project proposals, was approved via Resolution 23-94 by the C/CAG Board at their October 12, 2023 meeting.

Below are the highlights of the 2024 STIP:

- \$29,888,000 in to fund the construction phase of the US-101 Managed Lanes Project North of I-380, in FY27-28.
- \$5,000,000 to fund the construction phase of the Highway 1/Manor Drive Overcrossing Improvement Project in FY27-28.
- \$2,230,000 to fund the closeout phase of the US-101 Express Lanes Project Whipple to I-380. This funding reflects previously allocated STIP funds to this project which was returned to the 2024 STIP Fund Estimate.

After the C/CAG Board approved the 2024 STIP, Caltrans informed C/CAG Staff that \$2.23 million of funds for the SM101 Express Lanes Project (Whipple to I-380) is no longer needed. To preserve the funding within San Mateo County and within the earliest possible fiscal year and meet the guidelines and milestones of the 2024 STIP process, staff recommends re-allocating the \$2.23 million to the construction phase of the US-101 Managed Lanes Project North of I-380. It should be noted that the adoption of the 2024 STIP and this amendment recommendation does not commit the C/CAG Board to any of the project alternatives currently being analyzed for the US-101 Managed Lanes Project – North of I-380.

Recommendation

Staff requests that the C/CAG Board review and approve of Resolution 24-4 amending the funding allocation for the US-101 Managed Lanes North of I-380 Project in the 2024 State Transportation Improvement Program (STIP) for San Mateo County.

EQUITY IMPACTS AND CONSIDERATIONS

The nature of the STIP process requires the funds be "programmed" many years in advance. If there are equity concerns regarding the project, they will be identified in the future environmental analysis of the project development. However, the US-101 Managed Lanes Project North of I-380 continues to be identified as a project of countywide and regional significance to help expand the network of managed lanes in the Bay Area.

FISCAL IMPACT

The funding agreement amount is \$3,624,068. This is the cost for the construction, management and administration of the Smart Corridor expansion in the City of Brisbane.

SOURCE OF FUNDS

Funding for the agreement will come from State Transportation Improvement Program (STIP), and Local Partnership Program (LPP) funds.

BACKGROUND

The San Mateo County Smart Corridor project is a longstanding Agency priority. It is designed to improve mobility of local arterial streets by installing Intelligent Transportation System (ITS) equipment, such as an interconnected traffic signal system, close circuit television (CCTV) cameras, dynamic message signs, and vehicle detection system, on predefined designated local streets and state routes. The equipment is connected to underground fiberoptic communication infrastructure, enabling the equipment to communicate and share data with local transportation management centers (TMCs). The ITS infrastructure provides local cities and Caltrans with day-to-day traffic management capabilities to address recurring and non-recurring traffic congestion. The segments between City of San Bruno at the northern limits to the Santa Clara County line in the City of East Palo Alto has been completed. This portion of the project includes more than 238 intersections, 50 miles of fiberoptic communication cable, and 600 devices installed as part of the Smart Corridor. The devices include 270 CCTV cameras, 117 trailblazer/arterial dynamic message signs, and 40 vehicle detection systems. The South San Francisco expansion is currently in construction and is expected to be completed in 2024.

Continuing with the vision to build the Smart Corridor from the Santa Clara County line to the San Francisco County line, the Northern Cities segment is the next segment of the project. The project is a joint effort by the cities of Daly City and Brisbane, the Town of Colma, C/CAG, and the California Department of Transportation (Caltrans). The Northern Cities segment has completed design and is

construction ready. A map of the Northern Cities project corridors is included as Attachment 2 to the staff report. The City of Brisbane will manage construction of the segment located in Brisbane, while the City of Daly City will manage construction of the segment located in Daly City and Colma. This agreement is for the Brisbane segment only. The Daly City/Colma construction funding agreement was approved for execution at the December 14, 2023 Board meeting.

At the August 2023 California Transportation Commission meeting, the Commission programmed approximately \$9.9M for the construction of the Northern Cities segment. This will cover the construction costs for the Brisbane segment, the costs for the Daly City/Colma segment, and the cost for overall system integration.

The City of Brisbane will be the "Implementing Agency" leading the construction phase and administering construction contract. However, C/CAG will remain as the overall "Project sponsor" of the project. This funding agreement with the City of Brisbane outlines the obligations and responsibilities for the construction phase of the project. Separate agreements regarding the ongoing ownership, operations, and maintenance commitments will be forthcoming.

Staff recommends that the C/CAG Board approves and authorizes the C/CAG Executive Director to execute a funding agreement with the City of Brisbane in an amount not to exceed \$3,624,068 for the construction phase of the Brisbane Smart Corridor Expansion project.

EQUITY IMPACTS AND CONSIDERATIONS

The Smart Corridor is a countywide project aimed at improving mobility throughout the region. For the existing southern segments, the Smart Corridor has helped reduce traffic times along arterial roads during major freeway incidents. This benefits all road users, especially motorists who spend a larger portion of their income or time on transportation.

Additionally, the Smart Corridor system has positive impacts for non-motorists and other vulnerable populations. For example, the system can be used to implement transit signal priority, which can reduce travel times for transit riders. In Belmont, the City used Smart Corridor infrastructure to implement an adaptive traffic control system. This allowed the City to use real-time traffic conditions to change signal timing accordingly, which resulted in reduced congestion and improved access to schools. The Smart Corridor also includes dozens of trailblazer message signs installed along arterial roads to guide road users through detour routes. These wayfinding signs are especially beneficial for users that may not have a smartphone or internet access.



BACKGROUND

As part of an ongoing effort to enhance financial management and operational efficiency, C/CAG is building additional financial capacity within the agency. The City of San Carlos acts as the Agency's fiscal agent. Given the absence of a Finance Manager role to date, several key areas where targeted support and strategic planning are essential for the Agency's fiscal health and sustainability.

This includes dedicated support in the formulation, execution, and monitoring of budgets. To accurately allocate costs and resources across various programs, the establishment of a Cost Allocation Plan is imperative. This plan will streamline financial reporting and facilitate informed decision-making regarding resource allocation. In tandem with the immediate need for support, staff recognizes the necessity of defining the job scope and responsibilities for a permanent staff member dedicated to addressing the financial needs of C/CAG. This role can encompass a broad spectrum of financial activities, including budgeting, financial reporting, grants management, and compliance.

Consistent with C/CAG's procurement policy, staff solicited qualifications and rates from potential service providers and selected DKG Consultants to support various financial activities and identifying C/CAG's specific needs. C/CAG's Executive Director executed a contract for a not to exceed amount of \$45,000 (Attachment 1).

If awarded, RAISE program funding, together with Transportation Development (TDA) Article 3 and Congestion Relief Program funds would be used to cover the project costs.

BACKGROUND

On November 30, 2023, the U.S. Department of Transportation (USDOT) published a Notice of Funding Opportunity (NOFO) for \$1.5B in grant funding through the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary grant program for 2024. The popular program helps communities around the country carry out projects with significant local or regional impact. RAISE projects are evaluated on safety, environmental sustainability, quality of life, mobility and community connectivity, economic competitiveness and opportunities including tourism, state of good repair, partnership and collaboration, and innovation.

In 2021, C/CAG completed the most recent Comprehensive Bicycle and Pedestrian Plan update. C/CAG seeks to update the Plan every five years. For the next Plan update, C/CAG aims to provide a comprehensive analysis of existing and future bicycle and pedestrian infrastructure, with an emphasis on safety, sustainability, health, and social equity. The Plan will identify bicycle and pedestrian infrastructure gaps within the county to enhance multimodal transportation options; recommend projects that advance the reduction of greenhouse gas (GHG) emissions while advocating for the development of environmentally sustainable street infrastructure; and provide mobility options, such as an innovative e-bike strategy. The emphasis on this plan update will be to focus bike and pedestrian investments and improve access in traditionally underserved and disadvantaged communities, in a systematic and consistent manner across partner agencies. The Plan will also include a sidewalk inventory to identify unsafe and disconnected sidewalk infrastructure using advanced technology, such as drones and artificial intelligence. The e-bike component will address the feasibility of e-bike infrastructure (paths and charging stations) to mitigate congestion by enabling long distance inter-county travel and in recreational coastal areas. C/CAG will lead the Plan update, with major stakeholder outreach to the 21 incorporated jurisdictions, transit agencies, and the County, and members of the underserved communities.

This scope of work is approximately \$1,270,000. This Plan update fits well under the RAISE grant program mission and goals as stated above.

Staff recommends approving Resolution 24-7 supporting the submittal of a Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program funding application to update the C/CAG Comprehensive Bicycle and Pedestrian Plan, and to authorize the allocation of \$255,000 in local funds as match funds for the grant application.

Background:

The San Mateo County Express Lanes Joint Powers Authority (SMCEL-JPA) was jointly created by C/CAG and the San Mateo County Transportation Authority (SMCTA). The SMCEL-JPA is charged with overseeing the operations and administration of the San Mateo 101 Express Lanes, in addition to jointly exercising ownership rights over the Express Lanes.

The SMCEL-JPA commenced tolling on the 7-mile segment between Whipple Ave and the Santa Clara County line in February 2022, and on the 15-mile segment between Whipple Ave and I-380 in March 2023. In addition, the SMCEL-JPA funds and administers the San Mateo County Express Lane Community Benefit Program.

Major upcoming SMCEL-JPA tasks in the next two years include:

- a) Preparation of an Expenditure Plan.
- b) Expanding and improving the Express Lanes Community Benefits program (equity program).
- c) Preparation of an organizational assessment to analyze and advise on the different organizational models.

The Joint Exercise of Powers Agreement establishing the SMCEL-JPA states that the governing board will have a total of six members, including three Board members from C/CAG and three from SMCTA. In May 2023, the C/CAG Board of Directors appointed Alicia Aguirre, Michael Salazar, and Gina Papan for a 2-year term on the SMCEL-JPA Board. However, Gina Papan is no longer on the C/CAG Board of Directors. Consequently, she can not serve as the C/CAG appointee to the SMCEL-JPA Board. The C/CAG Board will have to appoint another member to fill the vacancy on the SMCEL-JPA Board.

Staff informed the C/CAG Board of Directors of the vacancy and requested letters of interest on January 12, 2024. By the requested deadline of 12pm on Thursday, February 1st, staff received one letter of interest from Richard Hedges, C/CAG Board Member and City of San Mateo Council Member.

Staff recommend appointing the new member through May 2025, which would complete the vacant term.

EQUITY IMPACTS AND CONSIDERATIONS

Appointing C/CAG Board Members to the SMCEL-JPA Board of Directors is a core C/CAG function. The SMCEL-JPA endeavors to enhance equity and improve mobility outcomes for low-income households through its Community Benefits program, which includes provisions such as a \$100 Clipper Card or FasTrak Transponder for eligible residents of San Mateo County. Additionally, the SMCEL-JPA supports regional efforts aimed at promoting equity by reducing fees and adopting a payment plan option.

The objective is to provide Board Members with background information to assist them in casting their votes. Nominations shall only be made by voting members of the Board of Directors. The Chairperson and Vice Chairpersons shall be voting members of the Board, as well. Nominations do not require a second or vote. Nominations for officers of the Board of Directors shall be made from the floor only at the regular February Board meeting. Nominations of the Chairperson shall precede nominations of the Vice Chairperson.

All nominated candidates should provide background information in advance of the March Board meeting such that the material can be included in the packet for the Board's consideration. For those candidates nominated, please provide the background information to Mima Crume (mcrume@smcgov.org) by February 23, 2024.

CURRENT OFFICERS:

Davina Hurt has served two terms as Chair and is not eligible to serve another term as Chair. Ricardo Ortiz has served two terms as Vice Chair and is not eligible to serve another term as Vice Chair.

Selection of a Chair and Vice Chair is required by the C/CAG By Laws.

ARTICLE IV. OFFICERS

Section 1. The officers of the Board of Directors shall consist of a Chairperson and one Vice Chairperson.

Section 2. The Chairperson and Vice Chairperson shall be elected from among the nominees by the Board of Directors at the March meeting to serve for a term of twelve (12) months commencing on April 1. There shall be a two-term limit for each office. That is, a member may not serve more than two consecutive terms as the Chairperson, and not more than two consecutive terms as Vice Chairperson. An officer shall hold his or her office until he or she resigns, is removed from office, is otherwise disqualified to serve, or until his or her successor qualifies and takes office.

Section 3. Nomination for officers of the Board of Directors shall be made from the floor only at the regular February Board meeting. Nominations shall be made only by voting members of the Board of Directors.

Section 4. The Chairperson and Vice Chairperson must be a regularly designated, voting member (e.g., not an alternate, or an ex-officio member) of the Board of Directors.

Section 5. Nominations and election of the Chairperson shall precede nominations and election of the Vice Chairperson. Voting shall be public for all offices.

Section 6. The Chairperson shall preside at all meetings of the Board, may call special meetings when necessary, and shall serve as the principal executive officer. The Chairperson shall have such other powers, and shall perform such other duties which may be incidental to the office of the Chairperson, subject to the control of the Board.

Section 7. In the absence or inability of the Chairperson to act, the Vice Chairperson shall exercise all of the powers and perform all of the duties of the Chairperson. The Vice Chairperson shall also have such other powers and shall perform such other duties as may be assigned by the Board of Directors.

Section 8. A special election to fill the vacant office shall be called by the Board of Directors if

the Chairperson or the Vice Chairperson is unable to serve a full term of office.

Section 9. All officers shall serve without compensation.

Section 10. The Chairperson or the Vice Chairperson may be removed from office at any time

by a majority vote of those members present at a duly constituted meeting of the Board.

RECOMMENDATION

FISCAL IMPACT

The total not to exceed amount for the development of C/CAG's first strategic plan is \$130,623.

SOURCE OF FUNDS

The adopted Fiscal Year 2023/2024 Budget includes funding for an agency strategic plan. This project will be funded with a combination of general operation funds, Congestion Relief Program funds, and contributions from the Stormwater and Energy programs.

BACKGROUND

C/CAG was initially formed to address common issues among members, and to adopt and implement state mandated countywide plans and programs, including congestion management, integrated solid waste management, airport land use and hazardous waste management. Over time, the Agency has evolved to tackle a number of additional issues that affect the quality of life of the community, including multi-modal transportation, air quality, climate change, stormwater runoff, and transportation/land use linkage. C/CAG provides a unique forum for the cities and the County to collaborate on common issues and develop cost-effective solutions.

With the successful completion of the Agency's Equity Assessment and Framework, and the significant policy and regulatory changes effecting the transportation, energy and stormwater fields, C/CAG is embarking to develop its first Strategic Planning to cover the next three to five years. Through a competitive procurement process, MIG Inc. (MIG) was selected to perform this work.

One of the tasks outlined in the Scope of Work is to hold two strategic planning workshops with the Board. The February Board meeting will be the first session. An outline of the planned activities is listed below.

• SWOT Analysis Presentation: MIG will present high-level findings from the strengths, weaknesses, opportunities and threats (SWOT) analysis, which includes the document and data review, in addition to input from the Board/staff survey, stakeholder interviews, and community focus group.

• Facilitated Priorities Discussion: MIG will facilitate a discussion with the C/CAG Board of

Directors to discuss the SWOT analysis findings and understand the key issues, priorities, and needs for the future of C/CAG. Board members are encouraged to prepare for the discussion by considering the following questions:

- 1. Assets and Strengths: What do you believe are C/CAG's greatest strengths as an organization?
- 2. Issues and Challenges: What do you believe are the biggest quality of life challenges facing San Mateo County in the next 3-5 years? What can C/CAG's role be in addressing these challenges?
- 3. Future Opportunities: What do you believe are the greatest opportunities for C/CAG to strengthen its support of C/CAG member agencies?

• Framework Discussion: MIG will facilitate a discussion with the C/CAG Board of Directors to begin the process of building a potential Strategic Plan Framework, so the Board can envision what the final product will look like. The Board will also be invited to help craft a vision statement for the agency. The current version of the agency mission has been in use for some time, albeit without formalization.

The mission statement is "C/CAG works on issues that affect the quality of life in general; transportation, air quality, stormwater runoff, airport/land use compatibility planning, hazardous waste, climate planning, energy and water resource strategies, and solid waste and recycling."

Board Members are strongly encouraged to attend this Board Session in-person if possible.

EQUITY IMPACTS AND CONSIDERATIONS

This item improves the administration/operations of C/CAG. C/CAG is currently implementing its Equity Assessment. The Strategic Planning process may identify additional desired equity outcomes or strategies.

BACKGROUND

The C/CAG Legislative Committee receives monthly written reports and oral briefings from C/CAG's State legislative advocate, Shaw Yoder Antwih Schmelzer & Lange (Consultant). Important or interesting issues and votes on positions taken by the Committee, or that arise out of the Committee meetings, are reported to the full C/CAG Board through this item.

The attached report (Attachment 1) from the Consultant may include various updates from Sacramento with respect to the legislative timelines, State Budget, State grant programs, recent committee hearings, and bill progress of interest to C/CAG since the Committee and Board last met. The 2024 Legislative Session began when the legislature reconvened on January 3, 2024. Remaining two-year bills will need to pass to the opposite house by the end of January to move forward. The deadline for new bills is February 16, 2024. The 2024 Legislative Calendar can be found here: 2024 Legislative Calendar.

At the Legislative Committee meeting, held prior to the Board meeting, the Committee will mainly

receive updates from the Consultant on State budget updates, and any additional information from Sacramento on bills discussed in the attached C/CAG Legislative Update. In addition, the consultant may discuss transportation funding and potential efforts to consolidate transportation agencies, and changes in legislative leadership and committee assignments.

State Authorizing Legislation for a potential future Regional Transportation Revenue ballot measure:

The Metropolitan Transportation Commission (MTC) has been discussed State Authorizing legislation to enable the region to put a regional transportation measure on a future ballot, possibly in 2026. The current schedule is to submit draft legislation in early 2024. The authorizing legislation does not require a regional ballot measure but provides the MTC the authority to pursue a regional measure. The C/CAG Legislative Committee, at its December meeting, discussed and voted to send a letter to MTC to reconsider inclusion of transit coordination/consolidation being included in the regional measure. The C/CAG Board voted in support of the letter in December.

EQUITY IMPACTS AND CONSIDERATIONS

The C/CAG Legislative Committee considers equity in its positions on legislation and has included equity language in the annual Legislative Priorities document for C/CAG Board review and approval. Decisions made in relation to transportation, housing, stormwater, and climate resilience have the potential to impact our most vulnerable communities in San Mateo County.

Re: STATE LEGISLATIVE UPDATE – February 2024

Legislative Update

The Legislature returned to Sacramento on January 3 to convene the second year of the two-year 2023-24 Legislative Session. Immediately upon their return, the Legislature's policy committees began to hear and act on bills introduced in the first year of the two-year session that did not move out of their first house (these bills are commonly referred to as "two-year bills"). Per the adopted 2024 Legislative Calendar, two-year bills still in their first policy committee are required to be acted on by January 22 to remain active, and all two-year bills must pass their first house by January 31. Governor Newsom Releases Proposed FY 2024-25 Budget

On January 10, Governor Newsom released his proposed <u>Fiscal Year (FY) 2024-25 budget</u>, based on the latest economic forecasts available to the Governor and his Department of Finance. Responding to a \$37.9 billion budget deficit (about half what the Legislative Analyst's Office estimated in December), the \$291.5 billion budget proposes to implement a series of funding delays and shifts (between fund sources) to maintain the state's commitments to addressing its top priorities – homelessness, education, public safety, and transportation.

The Governor is proposing to largely honor last year's \$5.1 billion transit funding deal. There is no proposed cut to the funds the Bay Area for transit operations and capital, only a proposed one-year delay of some TIRCP funding and fund source shift. The budget proposal does reduce the Active Transportation Program commitment by \$200 million.

The Governor is proposing cuts to housing programs, including reducing the REAP 2.0 program by \$300 million (about half of what was initially planned). The Administration has also indicated each region will be reimbursed for only half of their approved spending plans. The budget also proposes cuts to the Multifamily Housing Program and the Infill Infrastructure Grants Program.

Finally, \$54 billion identified in FY 2021-22 and 2022-23 budgets for various climate programs and the budget proposes to cut \$2.9 billion, delay \$1.9 billion, and shift \$1.8 billion from the General Fund to GGRF and other special funds. The budget proposes a \$221 million cut from sea level rise programs and \$171 million for coastal protection and adaptation.

Metropolitan Transportation Commission Approves Pursuit of Regional Transportation Measure, Identifies Framework for Investment

On January 24, the Metropolitan Transportation Commission (MTC) voted to pursue state legislation to enable Bay Area voters to consider a new regional transportation measure as early as November 2026. With this action, MTC also approved a framework for the enabling legislation, which outlines funding categories and potential revenue options, and which aims to generate \$1 billion annually. Funding categories included in this framework include: transit transformation, focused on sustaining and expanding transit service and supporting the transition to zero-emission technologies; safe streets, focused on bike and pedestrian infrastructure, safe routes to transit, and fixing potholes; connectivity, focused on relieving bottlenecks in the transportation network; and climate resilience, focused on funding planning, design, and/or construction activities that protect transportation infrastructure from climate change.

Bill language to expand on the framework will be introduced and amended into SB 925, the "spot bill" for the regional transportation measure in mid-February. The bill is expected to be heard in its first policy committee in the State Legislature in March.

Assembly Speaker Rivas Announces Committee Rosters

On November 21, Assembly Speaker Robert Rivas (D-Salinas) announced his much-anticipated changes to policy and fiscal committee chairs in the Assembly. On the heels of that announcement, on December 27, 2023, the Speaker further announced the full rosters for the Assembly's various policy and fiscal committees. You can find those rosters <u>here</u>.

California State Senate Announces Timeline for Leadership Transition

On December 4, 2023, the California State Senate announced that incoming Senate President pro Tempore Mike McGuire (D-Healdsburg) will take the gavel from current Senate President pro Tempore Toni Atkins (D-San Diego) on February 5, 2024. Following his inauguration as Senate President pro Tempore, Senator McGuire will name his new Senate leadership team and could appoint new chairs to various Senate committees.

Bills of Interest

SB 450 (Atkins) Updates to Ministerial Approvals for Parcel Subdivisions (SB 9) – C/CAG OPPOSE

This bill would make several changes to the ministerial approval process created by SB 9 for a housing development of no more than two units in a single-family zone (duplex), the subdivision of a parcel zoned for residential use into two parcels (lot split), or both by requiring that that an application for a duplex or a lot split shall be considered and approved or denied within 60 days from the date the local agency receives a completed application. If the local agency has not approved or denied the application in that timeframe, it shall be approved. SB 450 adds that if a local agency denies an application for a duplex or lot split, the permitting agency shall return in writing a full set of comments to the application with a list of deficient items and a description of how the application can be remedied by the

applicant. This bill would also prohibit a local agency from imposing objective zoning standards, objective subdivision standards, and objective design standards that do not apply uniformly to developments within the underlying zone. *This bill is in the Assembly.*

SB 532 (Wiener) Bridge Toll Increase

This bill would increase the toll for vehicles for crossing toll bridges in the San Francisco Bay area by \$1.50 until December 31, 2028, and require the revenues collected from this toll to be used by MTC for allocation to transit operators that provide service within the San Francisco Bay area and experiencing an operations funding challenge. Any transit operator seeking an allocation would be required to submit a 5-year projection of its operating need. *This bill is in the Assembly.*

SB 537 (Becker) Brown Act – Multijurisdictional, Cross-County Agencies

The bill would authorize the legislative body of a multijurisdictional, cross-county agency, as specified, to use alternate teleconferencing provisions if the eligible legislative body has adopted an authorizing resolution, as specified. The bill would also require the legislative body to provide a record of attendance and the number of public comments on its internet website within 7 days after a teleconference meeting, as specified. The bill would require at least a quorum of members of the legislative body to participate from locations within the boundaries of the territory over which the local agency exercises jurisdiction. The bill would require the legislative body to identify in the agenda each member who plans to participate remotely and to include the address of the publicly accessible building from each member will participate via teleconference. The bill would prohibit a member from participating remotely pursuant to these provisions unless the remote location is the member's office or another location in a publicly accessible building and is more than 40 miles from the location of the inperson meeting. The bill would repeal these alternative teleconferencing provisions on January 1, 2028. *This bill is on the Assembly Inactive File.*

SB 903 (Skinner) – PFAS Ban

This bill would state the intent of the Legislature to enact subsequent legislation to phase out the sale of products with avoidable perfluoroalkyl and polyfluoroalkyl substances.

SB 925 (Wiener) Bay Area Regional Measure

This bill, which is a "spot" bill for the nine-county regional transportation measure, would state the intent of the Legislature to enact subsequent legislation to authorize the Metropolitan Transportation Commission to propose a revenue measure to the voters in its jurisdiction to fund the operation, expansion, and transformation of the San Francisco Bay area's public transportation system, as well as other transportation improvements.

SB 926 (Wahab) Bay Area Transit Consolidation

This bill would require the California State Transportation Agency to develop a plan to consolidate all transit agencies that are located within the geographic jurisdiction of the Metropolitan Transportation Commission.

SB 960 (Wiener) Complete Streets Projects on the State Highway System

This bill would require all transportation projects funded or overseen by Caltrans to provide "comfortable, convenient, and connected complete streets facilities" unless exempt pursuant to the bill and would require the State Highway Operation and Protection Program (SHOPP) asset management plan to prioritize the implementation of "comfortable, convenient, and connected facilities" for pedestrians, bicyclists, and transit users on all projects in the program. The bill would require the CTC to adopt 4-year and 10-year objective targets and performance measures reflecting state transportation goals and objectives, including for complete streets assets that reflect the existence and conditions of bicycle, pedestrian, and transit facilities on the state highway system. The bill would require Caltrans and CTC to use the updated asset management plan and to guide the selection of transit priority projects for the SHOPP.

This bill would define "transit priority project" as a roadway design, operations, and enforcement action, treatment, or project that helps transit buses and other transit vehicles avoid traffic congestion, reduce signal delays, and move more predictably and reliably. The bill would require Caltrans to adopt a policy on transit priority projects for state and local highways and require Caltrans to take certain actions to streamline the approval of transit priority projects. The bill would require Caltrans to establish 4-year and 10-year targets for the fast and reliable movement of transit vehicles on state highways. Finally, this bill would require the Caltrans to establish a process to streamline the approval of pedestrian facilities, traffic calming improvements, bicycle facilities, and transit priority projects at locations where a local highway is above, below, or otherwise intersects with, a conventional state highway.

AB 817 (Pacheco) Brown Act – Advisory Bodies – C/CAG SUPPORT

This bill provides a narrow exemption under the Brown Act for non-decision-making legislative bodies to participate in meetings via teleconferencing outside of a declared state of emergency without posting the physical location of members or requiring a quorum to be present at a meeting location. *This bill passed the Assembly and is in the Senate.*

AB 1379 (Papan) Brown Act - Remote Meeting Flexibility – C/CAG SUPPORT

This bill also provides a broad interpretation of the Brown Act for all legislative bodies to participate in meetings via teleconferencing outside of a declared state of emergency without posting the physical location of members or requiring a quorum to be present at a meeting location, but would require a local agency to have a physical meeting location open to the public and follow certain notification procedures and meeting procedures. *This bill failed the two-year deadline.*

AB 1798 (Papan) Stormwater Runoff

This bill would require Caltrans and the State Water Resources Control Board, the Department of Toxic Substances Control, and the Department of Fish and Wildlife, to develop a programmatic environmental review process to prevent toxic compounds generated from vehicle tires from entering salmon and steelhead trout bearing waters. The bill would require Caltrans' process to include a pilot project at an unspecified location to study the effectiveness and cost effectiveness of installing and maintaining bioretention and biofiltration systems. *C/CAG supported a similar bill in 2023 and should consider a SUPPORT position on this bill.*

AB 1837 (Papan) Bay Area Transit Coordination

This bill, which is a spot bill, would state the intent of the Legislature to enact subsequent legislation to encourage coordination and collaboration among transit agencies in the San Francisco Bay area.
