SMCWPPP FY 2023-24 Annual Report

Action: Approval of the Draft SMCWPPP FY23-24 Annual Report, pending any final revisions

Process:

- FY 2023-24 Annual Reports are due by Sept 30, 2024
- Once finalized, permittees will certify and submit the Program Annual Report with their jurisdictional Annual Reports via the SMARTS application
- Permittees should ensure current LRPs and DARs are set up and e-certified in SMARTS

- Sept 11 RWB Trash Information Item (progress toward 100% trash load reductions by June 30, 2025)

Program Information/Announcements

- Long-term GSI Technical Workgroup (TWG)
- MRP 3.0 allows formation of Technical Workgroup to address long-term GSI goals and recommend long-term percentage reductions in Permittees' impervious surfaces, at individual, countywide and regional scales
- Also suggests addressing goals for projects not currently regulated in the MRP and climate/resilience benefits and performance metrics
- MRP requires a report documenting efforts and recommendations for MRP 4.0 submitted with 2024-25 Annual Reports (not focused on MRP 3.0 GSI retrofits)



Program Information/Announcements

- Long-term GSI Technical Workgroup (TWG)
 - TWG includes permittee and program reps as well as Regional Water Board staff (and may involve other technical experts)
 - Meeting quarterly this FY and once annually thereafter for MRP 3.0 (first meeting was Sept 13)
 - SMCWPPP requested participation from San Mateo Permittees involved in regional projects given overlap with long-term GSI implementation in the County, but still seeking permittee representation (contact program staff with interest)
- Future updates at Stormwater Committee

 - Revised Report submitted July 23
 - Ongoing coordination with permittees on ROW and site investigations
- EPA SF Bay Program Office non-competitive grant for FY23 funds (project to begin early 2025)

Program Information/Announcements

- State Water Board Stormwater Permit Fees FY2024-25
 - Fee increase for first time in two FYs
 - Increase of 3% for FY24-25 fees
 - Approved by the SWB on Sept 18



Program Information/Announcements

- Civil Grand Jury Report: Restaurant Exteriors: The Neglected Space (7 Findings):
 - F1-5 regarding sanitary conditions of restaurant exteriors (parklets, sidewalks, waste storage areas) refer specifically to the County Health Department and inspections of these areas falling outside of the County's existing the food facility inspection program.
 - F6 specifically addresses issue of wash water and runoff from trash storage areas being susceptible to flowing into the MS4.
 - F7 addresses limitations on effective inspections of parklet areas due to access issues of debris buildup.



Program Information/Announcements

- Civil Grand Jury Report: Restaurant Exteriors: The Neglected Space (4 Recommendations):
 - R1/2 – By June 30, 2025 County should amend its Food Facility Checklist to address trash conditions and repairs/replacement/cleaning needs
 - R3 – By June 30, 2025 County should require restaurants to have diagram of approved waste storage/retention areas for inspections
 - R4 – by June 30, 2025 inspectors for all jurisdictions with restaurants should be empowered to require owners/operators to add receptacles/increase pickups



Program Information/Announcements

- Civil Grand Jury Report: Restaurant Exteriors: The Neglected Space (Action):
 - Councils from all 20 cities and towns required to respond to F1-6 and R4 by June 30, 2025
- Considerations:
 - County Health no longer conducts inspections for the municipalities so each agency is responsible for addressing these issues and should respond accordingly
 - Existing business inspection programs account for priority of sites for inspections based on type of facility and past performance (refer to Business Inspection Plans)
 - Franchise agreements may constrain receptacles/pickup frequency
