Meeting was called to order at 3:06 P.M.

1. Roll Call and Introductions, including welcoming members recently appointed by the C/CAG Board to the RMCP Committee.

Committee staff completed Roll Call and a quorum of 10 members was eventually achieved. The Committee welcomed new member Betsy Nash, Menlo Park City Council Member.

2. Public Comments on items not on the agenda.

There were no public comments.

3. Approval of minutes of the May 15, 2024 and August 21 2024 RMCP Committee meetings.

The Committee approved the minutes of the May 15, 2024 meeting, with a motion by Member Papan, seconded by Member Lopez. A vote was taken and passed (6,2,0) with two members, Nash and Chiang, abstaining. The Committee approved the minutes of the August 21, 2024 meeting, with a motion from Member Papan, seconded by Member Hubbard. A vote was taken and passed (6,2,0) with two members, Nash and Chiang, abstaining. Members Hufty and Beckmeyer were not present for the voting.

4. Presentation on Regionally Integrated Climate Action Planning Support emissions inventory history, process, and trends.

Ryan Gardner, Rincon Consultants, provided a presentation on the RICAPS climate action planning emissions inventory program. Gardner's presentation included each of the source categories of emissions and the sources. Gardner continued by providing emissions reduction trends for San Mateo County since 2005 through 2022. Challenges with changing methodologies and data sources was also discussed. The Committee commented or asked questions on the following: how residential, commercial, and industrial data is broken down, the future of merging gas station with EV charging, the importance of EV charger maintenance, PG&E's focus on full electrification, challenges with timing for energization, why electricity emissions is not closer to zero and what PCE's energy mix is, the drop in organic waste into landfills, potential expansion of hydroelectric, and the applicability of Proposition 4 to these efforts to reduce emissions.

5. Presentation on regional input for city- and county-level GHG emission inventories in development of statewide inventories by UC Berkeley Energy and Resources Group.

Chris Jones, UC Berkeley Energy and Resources Group and Miya Kitahara from StopWaste Alameda County provided a presentation on the development of inventories by city on a statewide basis. The point was made that success in reducing greenhouse emissions depends on both state, regional, and local action. Completing emissions inventories is a very costly process for each city to undertake, but more economical at economies of scale. The RICAP program has been completing inventories for cities in San Mateo County, but most counties do not have such a vehicle. The UC Berkeley effort, with input from multiple stakeholders, seeks to establish a system for generating emission inventories for all cities in the State, both resource- and consumption-based. The Committee commented or asked questions on the following topics: How to, potentially, improve upon MTC's data, gratitude that this is a "no cost" process at this point, and how helpful it will be to have more data on full deployment needs of EV charging infrastructure.

6. Presentation on BAWSCA Regional Water Demand and Conservation Projections Study.

Item 3

Negin Ashoori, Senior Water Resources Engineer at BAWSCA, provided a presentation on the BAWSCA Regional Water Demand and Conservation Projections Study that is carried out by BAWSCA for its water agencies approximately every five years. Despite growing population (34%), the demand has decreased (-32%). The demand and conservation study has two objectives, demand projections and a sensitivity analysis. The Study will also be simulating the impact of future drought. The Committee and public provide comments or asked questions on the following topics: how it is that population could be unbundled from water use, how will the Study treat the Bay Delta Plan and are there any new sources of water being considered, how will the most recent regional Housing Needs Assessment be factored in, and will the plan be affected by ground water pressure and rise due to sea level rise.

Meeting was called to order at 3:06 P.M.

1. Roll Call and Introductions, including welcoming members recently appointed by the C/CAG Board to the RMCP Committee.

Committee staff completed Roll Call and five members were in attendance.

2. Public Comments on items not on the agenda.

There were no public comments.

3. Approval of draft minutes of the September 18, 2024 RMCP Committee meeting.

Due to lack of quorum, this item was postponed to the next Committee meeting.

4. Presentation on Proposition 4 and expected funding allocations in alignment with climate programs.

C/CAG and Committee staff, Kim Springer, gave a brief presentation on the proposed funding under Proposition 4. The committee discussed and provided comments related to the potential for stormwater funding and for dam repair, funds for water conservation, and whether there was any polling on the proposition.

5. Presentation on EV.PRO electric vehicle as a service model for city or commercial fleets.

Ashley Rich, Chief Customer Officer with EV.PRO, provided a presentation on the EV as a service model being marketed by EV.PRO, including the pros and cons of ownership vs. EV as a service, the approximate cost, the process for setting up a program, and what happens at the end of the 5-year lease.

The Committee discussed and commented on the presentation, including the following topics: the location of EV.PRO as a company and its territory, if the Service would work for hotels, where the cost savings for customers comes from, would union fleet managers be concerned about their reduced role, public agencies fit due to medium duty vehicles, and police and parking compliance vehicles.

6. Presentation on new energization rules adopted by the California Public Utilities

Chris Moore, Local Government and Community Outreach at the CPUC, provided a presentation on new regulations related to evaluation and interconnection (energization) request turnaround times for electric utilities. The Committee discussed and provided comments on the following topics: current IOU response rate trends, acceptability of new timelines, what the start day of the “counter” for the new regulations, How local government can help drive shorter timelines, can IOUs be fined for failing to meeting the new timelines, what the constraint is on the utility side for reducing timelines, how to educate the public in advance of appliance failure, the importance of developing technologies and approaches of reducing the need for panel upgrades, and other challenges with electrification of transportation.

Public attendees provided the following comments: having a specific contact at PG&E would be helpful, and there are possibilities for electrification without panel upgrades.

7. Presentation on Bay Area Air Quality Management District update on amending Regulation 9, Rules 4 and 6 to reduce emissions of nitrogen oxides from residential and commercial furnaces and water heaters, and California Air Resources Board’s outreach effort for Zero-Emission Space and Water Heater Standards.

Item 3

Richard Chien, Advanced Projects Advisor at BAAQMD, provided a presentation on new Air District rules designed to reduce nitrous oxide pollutants and the Air Resources Board's outreach efforts in development of zero-emission appliance standards. The presentation included Air District authority and rule amendments, emissions and health benefits, the implementation working group efforts, and next steps.

The Committee discussed and commented on the information in the presentation, including the need for a focus on displacement of seniors who are living on the edge of affordability, addressing low income and coastal residential resilience, training related to permitting, the need for retail outlets and contractors to help lead the transition before 2027, and outreach to renters so they know their rights.

Public comment included how the new Air District rules will help support the reach code effort, some of which have been rescinded, and an example of a successfully retrofitted multi-family unit in the San Mateo County.

8. Committee Member Updates

Member Sarah Hubbard provided some updated and event announcement for Sustainable San Mateo County.

Sean Charpentier, C/CAG ED, reminded the Committee of the \$60M MTC grant currently open and encouraged application. Charpentier also reminded the Committee that a recruitments letter for open seats on C/CAG committees will be going out shortly.

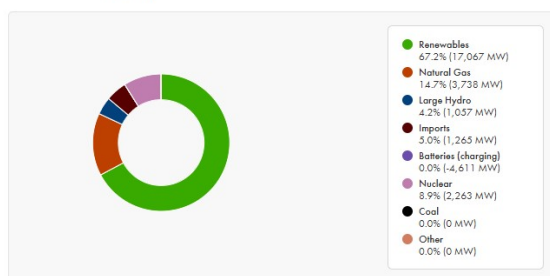
BACKGROUND/DISCUSSION

The clean energy transition means shifting energy production away from sources that release a lot of greenhouse gases, such as fossil fuels, to those that release little to no greenhouse gases. Nuclear power, hydro, wind and solar are some of these clean sources.

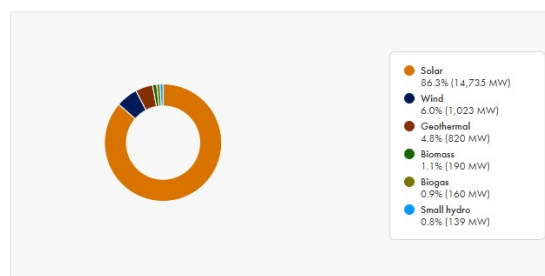
As of mid-2012, California had one operating nuclear power plant, the Diablo Canyon Nuclear Power Plant near San Luis Obispo. PG&E owns the Diablo Canyon Nuclear Power Plant, which consists of two units: a 1,073-megawatt reactor, which began commercial operation in May 1985, and a 1,087-megawatt reactor, which began commercial operation in March 1986. This power plant near Avila Beach in San Luis Obispo continues to operate after a plan to decommission both reactors in 2024 and 2025 respectively, based on SB 846, which provided for an extension of the operation of the facility.

The facility provides a steady source of electricity, 8-10% of the needs of the State of California. California also purchases nuclear power from other states such as Arizona and Nevada. The following is a look at California’s energy supply on a typical fall day:

BACKGROUND/DISCUSSION

Peninsula Clean Energy (PCE) is a joint powers agency formed as a Community Choice Aggregation (CCA) program by San Mateo County and all 20 of its cities and towns in 2016. PCE, as the community-led electricity provider for San Mateo County and for the City of Los Banos, is focused on providing clean electricity at lower prices than PG&E and investing proceeds back into the community. PCE has the flexibility and local control to use innovative options in purchasing and generating electricity for residents and businesses, and a Power Resources Team with a goal of continuing to provide energy that is 100% clean and that will be 100% renewable by 2030. The following chart shows PCE’s 2023 energy mix:

BACKGROUND/DISCUSSION

The Alliance for Renewable Clean Hydrogen Energy Systems (ARCHES) Hydrogen Hub, also known as the California Hydrogen Hub, is a statewide initiative aimed at developing a network of clean, renewable hydrogen production sites across California, with the primary goal of decarbonizing heavy-duty transportation sectors like trucking, public transit, and port operations by utilizing hydrogen as a fuel source, significantly reducing carbon emissions across the State. Funded by the federal government via the U.S. Department of Energy (DOE), ARCHES announced the official signing of a \$12.6 billion agreement to build a clean, renewable Hydrogen Hub in California, including the up to \$1.2 billion in federal funding that was announced last year when California was selected as a national hub. ARCHES was the first of seven Hydrogen Hubs throughout the country to officially sign their agreement with the DOE.

ARCHES will serve three large ports with over 200 pieces of cargo-handling equipment, fund some 5,000 fuel-cell-electric trucks, 1000 fuel-cell-electric busses, a marine vessel, stationary generation, and both fueling stations and pipelines.

Besides reducing GHG emissions, the effort is expected to create 200,000 new jobs, savings from better health and health cost savings, and 40% of the funding will flow to disadvantaged communities through investments, workforce development, and jobs.

Lew Fulton, Director of Energy Futures Program at UC Davis and Chair of the ARCHES Transportation Working Group, will provide a presentation on the ARCHES project. A link to the ARCHES website is provided as an attachment to this staff report.
