

**AMENDMENT NO. 2
TO THE
AGREEMENT BETWEEN
CITY/COUNTY ASSOCIATION OF GOVERNMENTS OF SAN MATEO COUNTY
AND
FEHR & PEERS**

This Amendment No. 2 to the Agreement between CITY/COUNTY ASSOCIATION OF GOVERNMENTS OF SAN MATEO COUNTY, a joint powers agency whose members include the County of San Mateo and the twenty incorporated cities and towns within San Mateo County, hereinafter called "C/CAG," and Fehr & Peers, hereinafter called "Consultant."

WITNESSETH

WHEREAS, pursuant to C/CAG Board Resolution 24-9, C/CAG and Consultant entered into an Agreement on June 10, 2024 for a term ending on September 30, 2024 and an amount not-to-exceed \$15,000; and

WHEREAS, the Agreement provides that the Consultant will provide maintenance services for the San Mateo Countywide Vehicle Miles Traveled (VMT) Estimation Tool; and

WHEREAS, Amendment No. 1, executed on December 9 2024, extended the term of the Agreement from September 30, 2024 to January 30, 2025; and

WHEREAS, C/CAG and Consultant desire to amend the Agreement to extend the term to April 30, 2025.

NOW, THEREFORE, IT IS HEREBY AGREED by the C/CAG and Consultant that:

1. Contract Term Termination shall be amended as follows (additions in *italics*, deletions in ~~strike through~~):

This Agreement shall be in effect as of June 10, 2024, and Consultant shall commence work after notification to proceed by C/CAG Project Manager, and the Agreement shall terminate on ~~January 30, 2025~~ *April 30, 2025*; provided, however, the C/CAG Chairperson may terminate this Agreement at any time for any reason by providing 30 days' notice to

Consultant.

2. Full Force and Effect. All other provisions of the Agreement shall remain in full force and effect.
3. Effective Date. This Amendment shall be deemed retroactively effected as of January 30, 2025 upon signature by both Parties.
